Project Selection Committee 6/12/2023 Recommendations – Ashley Bryers, Peter Mohr, Chad Parasa, and Nick Flanders, WAMPO On June 12, 2023, the WAMPO Project Selection Committee (PSC) met and made project-funding 16-19 recommendations that the TAC is now asked to decide whether or not to forward to the TPB for final action. First, in response to submissions for a special Call for Projects (March 1-May 1, 2023), they recommended five (5) specific projects to which to award approximately \$3.9 million (cumulatively) of Carbon Reduction Program (CRP) in FFY2024-FFY2025. Then, they recommended permitting \$131,559 of unused Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA) from the WAMPO project "WAMPO Travel Demand Model Update" to

#### C. Director's Report

#### i. Electric Vehicle Plan Update

Dora Gallo, WAMPO, gave an update on the first Electric Vehicle Plan steering committee meeting, at which they discussed the purpose of the plan, current funding opportunities, committee roles, and current EV charging stations in the region. The steering committee participated in activities to brainstorm the vision and goals for the EV Plan and potential EV charging locations.

**ii. Project Selection Committee meeting for Carbon Reduction Program funding** Chad Parasa, WAMPO, said that there is a doodle poll that was sent to PSC members to schedule the next meeting.

#### 3. Public Comments

There were no public comments.

#### 4. Action

#### A. 2023 UPWP Amendment 2

Ashley Bryers, WAMPO, said that a version of Amendment 2 to the 2023 WAMPO Unified Planning Work Program (UPWP) was reviewed by the TAC in April but was not taken before the TPB for their approval because additional changes to the UPWP needed to be added to the amendment. The TAC is asked to make a recommendation on revised, proposed Amendment 2 to the 2023 UPWP to consolidate travel line items, adjust all staff line items to reflect actual hours worked, adjust the budget to accommodate anticipated expenditures based on planned work, add \$110,000 for "Consulting Services: Accounting Services" to the budget, and add the development of bicycle/pedestrian-facility maps for public use using the latest technology, such as mobile apps. The public comment period is 5/17/2023 through 6/1/2023. No public comments have been received to date.

#### 5. Discussion/Updates

#### A. KDOT Safe System Approach: Post-Crash Care

Vanessa Spartan, KDOT, and Susan DeCourcy, National Highway Traffic Safety Administration, presented the TAC members with important crash information. They discussed the safe system approach and various initiatives and efforts aimed at improving road safety and emergency medical services. The safe system approach has been embraced by the transportation community as a way to address and mitigate the risks in our transportation system.

Ms. DeCourcy presented the mission of the NHTSA's Office of Emergency Medical Services, emphasizing the importance of emergency and trauma care in saving lives. She highlighted the significance of providing effective medical care to crash victims promptly. Ms. DeCourcy also mentioned that there has been a significant increase in funding for road safety in Kansas. The federal Bipartisan Infrastructure Law (BIL) has provided nearly \$14 billion in new funding for the country, representing a 50% increase compared to previous allocations. This increased funding aims to enhance road safety measures in the state.

Ms. Spartan discussed the Kansas Drive to Zero Coalition, which consists of 22 members, including federal and state agencies, the private sector, nonprofits, and representatives from the Kansas House and Senate. The coalition focuses on promoting road safety and reducing traffic fatalities in Kansas. She further highlighted recent studies undertaken by Kansas, such as the reassessment of emergency medical services and an ambulance service assessment. These studies aim to evaluate and improve the efficiency and quality of emergency medical services in the state. Currently, there is an ongoing study in rural Kansas that focuses on identifying the "golden hour," which refers to the critical time immediately after a crash when prompt medical attention is crucial. This study aims to determine the optimal strategies for providing timely medical care in rural areas.

#### **Discussion:**

Chad Parasa said WAMPO staff would like to help and collaborate with the safe system approach. WAMPO is currently conducting a study on the safe system approach for its Comprehensive Safety Action Plan (CSAP), exploring how everyone in the state can come together to coordinate efforts in channeling the message. Safe Streets and Roads for All (SS4A) grant applications are due July 10<sup>th</sup>.

Justin Shore asked if KDOT tracks first-responder-only facilities in addition to ambulance facilities. Ms. Spartan responded that that is not something they have studied yet.

Jack Brown asked if there are standards for optimal response time to a crash. A response was sent to Mr. Brown and the entire TAC membership after the meeting.

#### B. CSAP Update - Crash Causes, Next Steps, and SS4A Grant Application

Kendra Schenk, Burgess & Niple, and Slade Engstrom, TranSystems, presented on the project and provided a status report on the development of the Comprehensive Safety Action Plan (CSAP), including crash causes, plan milestones, and the Safe Streets and Roads for All (SS4A) grant application.

Last week, at the 3<sup>rd</sup> TSTA meeting, committee members reviewed a few intersections within walking distance from WAMPO's offices. WAMPO will be applying for a demonstration grant to pilot programs, while an implementation grant would require the CSAP to be completed. The TSTA has chosen to pursue the demonstration-grant option as the plan won't be completed in time to pursue an Implementation grant in July. To ensure success, they are planning to engage the public and identify areas in need of safety improvements. The consultant will conduct a community needs assessment, collaborate with local community organizations, hold public meetings, and gather input from residents to pinpoint specific locations that require attention.

**Discussion:** Mr. Parasa said that the next CSAP meetings will be in coordination with cities and KDOT. There is a safety workshop and open house at Bike Walk Wichita on June 8<sup>th</sup> from 4:00-6:00 PM.

#### C. MTP 2050 Update - Survey and Milestones

Ms. Bryers mentioned that WAMPO is currently conducting a survey and attending different popup events for public engagement. Ms. Bryers said that the MTP 2050 Call for Projects will open on September 15, 2023 (during the meeting Ms. Bryers misspoke and corrected herself in the Other Business section).

### **Executive Summary**

The WAMPO TIP Policy includes a Reasonable Progress Policy, under which projects receiving WAMPOsuballocated funding in the current FFY or that received it in a past FFY but are not completed are to have bimonthly progress reports to the TAC/TPB. This is the progress report to the TAC for June 2023.

## Background

Page 23 of the WAMPO Transportation Improvement Program (TIP) Policy (Appendix I of the FFY2023-FFY2026 TIP, <u>https://www.wampo.org/\_files/ugd/bbf89d\_646ba786b67646b98cfe14f74bcc0277.pdf</u>) establishes a Reasonable Progress Policy. This policy states that projects programmed to receive WAMPO-suballocated funding that are scheduled to start in the current Federal Fiscal Year (FFY) or that have started but not finished (including projects that started in prior FFYs) are supposed to have progress reports at least every two months. The attached project statuses have been reported for the June 2023 bimonthly report to the TAC.

The Reasonable Progress Policy was revised by the TPB on April 11, 2023, but these bi-monthly progress reports were kept as part of it.

## **Executive Summary**

WAMPO and a consultant team are developing a Comprehensive Safety Action Plan (CSAP) for the region. In support of that effort, they are putting together a Planning and Demonstration grant application for the Safe Streets and Roads for All (SS4A) discretionary grant program, due on July 10, 2023. WAMPO is asking for letters of support by 5 pm on June 27, 2023.

#### Background

WAMPO is in the process of developing a Comprehensive Safety Action Plan (CSAP). Upon its expected adoption in late summer/fall 2023, the WAMPO region will be eligible for U.S. Department of Transportation (USDOT) discretionary Safe Streets and Roads for All (SS4A) Implementation grants. Additional information about the Comprehensive Safety Action Planning process is available at <u>www.wampo.org/safety</u>.

The SS4A Notice of Funding Opportunity (NOFO) for this year was published earlier than expected, with the result that grant applications are due on July 10<sup>th</sup>, 2023, prior to the expected adoption of the WAMPO CSAP, meaning the WAMPO region will not be able to apply for any Implementation grants during this round of funding. Instead, WAMPO staff and consultants are putting together a Planning and Demonstration grant application. WAMPO intends to then apply for an Implementation grant in 2024 or 2025.

## **Executive Summary**

WAMPO staff are attending public meetings and holding pop-up events in May-July 2023 to promote this survey and gather responses. In addition to collecting input through the survey, ten stakeholder listening sessions will be held in June and July 2023.

### **Executive Summary**

WAMPO is developing an Electric Vehicle Plan for the region. The plan-development process is currently in the public engagement phase, for which a public survey will soon be launched that will help WAMPO understand needs and identify potential goals and strategies for this plan.

## Background

The Electric Vehicle Plan will outline the first steps the region can take to support and encourage electricvehicle (EV) adoption, deliver a comprehensive course of action to provide EV charging infrastructure, and remove barriers to further efficient and effective EV adoption in the WAMPO region. This plan will serve as a starting point for private and public entities to grow more familiar with the opportunities and challenges related to electric vehicles, charging infrastructure, and the adoption thereof.

The Electric Vehicle Plan will support the Metropolitan Transportation Plan 2050 (MTP 2050) and the Charge Up Kansas National Electric Vehicle Infrastructure (NEVI) Plan by advancing the use of EVs to improve air quality and foster economic development. WAMPO has an opportunity to adapt to emerging technologies by closing EV-charging infrastructure gaps and removing barriers to EV adoption.

### **Executive Summary**

On June 12, 2023, the WAMPO Project Selection Committee (PSC) met and made project-funding recommendations that the TAC is now asked to decide whether to forward to the TPB for final action. First, in response to submissions for a special Call for Projects (March 1-May 1, 2023), they recommended five (5) specific projects to which to award approximately \$3.9 million (cumulatively) of Carbon Reduction Program (CRP) in FFY2024-FFY2025. Then, they recommended permitting \$131,559 of unused Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA) from the WAMPO project "WAMPO Travel Demand Model Update" to be placed on a "phase 2" TDM-update project, provided that recent Federal legislative actions allow it.

## **Background: CRP Funds**

WAMPO has a new sub-allocated funding program, the Carbon Reduction Program (CRP). Following a special Call for Projects (March 1-May 1, 2023), the WAMPO Project Selection Committee (PSC) met on June 12, 2023, and made recommendations to the TAC and TPB on which projects should receive funding from this new source. During the Call for Projects, six projects were submitted (see attached table and map).

#### Available Funds and Eligible Uses

When the Bipartisan Infrastructure Law (BIL) was enacted in late 2021, it created the <u>Carbon Reduction</u> <u>Program (CRP)</u>, which funds transportation projects that are expected to reduce carbon dioxide emissions. A summary of the types of projects that qualify for CRP funds may be found in the CRP Call for Projects flyer (see attached).

Each year, a portion of the CRP funds allocated to Kansas are sub-allocated to WAMPO to award to specific projects, in a similar fashion to WAMPO's other sub-allocated funding programs (Surface Transportation Block Grant (STBG), Congestion Management and Air Quality (CMAQ), and Transportation Alternatives (TA)). Due to delays in the creation and distribution of Federal and State guidance on the program, WAMPO now has three years' worth of CRP funding to distribute:

## **Background: CRRSAA Funds**

In Federal Fiscal Year (FFY) 2022, \$700,000 of Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA) funds were obligated on the WAMPO project "WAMPO Travel Demand Model Update". However, the contract with the consulting firm selected to carry out the project was ultimately for only \$568,441. Therefore, <u>contingent on State and Federal rules and procedures allowing it</u>,<sup>1</sup> WAMPO staff proposed to the PSC to deobligate the excess funds and reprogram them onto a "phase 2" project, starting in FFY2024, that would continue the work of keeping the Travel Demand Model (TDM) up to date.

#### **Proposed Year of Obligation** FFY2024

#### Proposed Project Scope

- 1. Conduct routine model maintenance and testing for errors. This will include working with a modelvalidation taskforce made up of representatives from WAMPO member jurisdictions and planning partners to get their input on updates to the model.
- 2. Keep the model and its input data up to date and account for current and future changes in the transportation network and future development of the Wichita region. Sources of updated information could include, but are not limited to, the following:
  - a. Updates made to the model by other users, including KDOT, local governments, and consultants retained by KDOT and/or local governments for planning and engineering work.
  - b. Road-centerline Geographic Information System (GIS) data, American Community Survey data, traffic-count data, building-permit data, and transit-route data.
- 3. In response to requests from WAMPO planning partners and member jurisdictions, provide maps, Excel spreadsheets, GIS shapefiles, and text with analysis regarding the model's outputs, performance measures, and degree of sensitivity under its current configuration. Requested data

types may include, but are not limited to, average travel speeds, travel times, link delays, capacities, and levels of service. Subarea analyses may also be requested.

- 4. For WAMPO studies and reports, provide maps, Excel spreadsheets, GIS shapefiles, and text with analysis regarding the model's outputs, performance measures, and degree of sensitivity under its current configuration. This may include, but is not limited to, average travel speeds, travel times, link delays, capacities, and levels of service. Subarea analyses may also be requested.
- 5. Attend WAMPO committee meetings and meetings with WAMPO regulators, planning partners, or stakeholders, as requested by WAMPO staff, to speak about the model and its uses, data requirements, and outputs, either with or without WAMPO staff present.
- 6. Participate in meetings with the WAMPO project manager to review progress, answer questions, and plan next steps on a regular basis.

## **Fiscal Considerations: CRP Funds**

FFY2022 CRP funds are required to obligate no later than the end of FFY2025. The PSC's recommendations would result in all unawarded FFY2022, FFY2023, and FFY2024 CRP funds being obligated before they expire, in either FFY2024 or FFY2025.

## **Fiscal Considerations: CRRSAA Funds**

CRRSAA funds are required to obligate no later than the end of FFY2024. The PSC's recommendation on the use of CRRSAA funds would make it possible for unused funds to reobligate before they expire, depending on the outcome of recent federal legislation. Because CRRSAA funds may be used for up to 100% of a project's cost, WAMPO's operating budget would not be adversely affected.

## **Executive Summary**

WAMPO's Reasonable Progress Policy requires sponsors of projects programmed to receive WAMPOsuballocated funding in the current FFY that are not yet obligated to present their statuses to the TAC at their first meeting after May 31 and to the TPB at their first meeting after that. In FFY2023, one Haysville project, one Wichita project, and one Valley Center project fall into this category.

## Background

Page 23 of the WAMPO Transportation Improvement Program (TIP) Policy (Appendix I of the FFY2023-FFY2026 TIP, <u>https://www.wampo.org/\_files/ugd/bbf89d\_646ba786b67646b98cfe14f74bcc0277.pdf</u>) establishes a Reasonable Progress Policy. This Reasonable Progress Policy was revised by the TPB on April 11, 2023. One of the changes made on that occasion was to establish that:

"At the TAC meeting following May 31st and the TPB meeting following that TAC meeting, project sponsors with projects in the current FFY not obligated will be required to present their project's status, both verbally and in writing, and be available to answer questions from the TAC and TPB. On this occasion, they may also request additional time to obligate, if necessary."

There are three Federal Fiscal Year (FFY) 2023 projects that, as of June 2023, have not yet obligated their WAMPO-sub-allocated funds, meaning the sponsors of those projects are required to report on their statuses to the TAC and TPB both in writing and verbally:

- » Haysville: "Seneca & 63rd Street Bike Ped Pathway"
- » Wichita: "West St., Harry to Pawnee"
- » Valley Center: "Meridian, from Ford (77th St. N.) to Seward (69th St. N.) and Main to 5th (85th St. N.)"

## **Executive Summary**

The Center for Economic and Business Research (CEDBR) will provide a presentation regarding their socioeconomic and demographic findings for the WAMPO region, including housing affordability, employer retention and attraction factors, and key corridors serving the WAMPO area.

## Background

The Center for Economic Development and Business Research (CEDBR) has completed extensive demographic and socioeconomic research across Kansas and in the WAMPO region. They recently compiled the WAMPO Regional Housing Cost Report and Index. This report describes housing affordability in the WAMPO region and how such affordability in the Wichita area may benefit employees and employers alike. In addition, CEBDR has compiled data detailing how specific local job talent, certain capital-intensive infrastructure, and key road corridors have given the WAMPO region a net benefit in both retaining current large employers and attracting new ones.

### **Executive Summary**

The 5310-grant program provides federal funding to enhance transportation options for seniors and individuals with disabilities in the United States. It supports services beyond traditional public transportation and aims to improve access to essential services and community activities. Funding can be used for vehicles, operational costs, training, and transportation plans. Wichita Transit manages the Section 5310 grant, with available funding 2021 and 2022 funding totaling \$1,077,144. WAMPO led the call for projects and grant selection process.

## Background

The 5310-grant program, also known as the Enhanced Mobility of Seniors and Individuals with Disabilities program, is a program administered by the Federal Transit Administration (FTA). It provides funding to states and localities to enhance mobility options for seniors and individuals with disabilities.

The program focuses on supporting transportation services that go beyond traditional public transportation, such as paratransit, wheelchair-accessible vans, and other specialized vehicles. The goal is to improve access to essential services and community activities for individuals who may face challenges using regular fixed-route public transportation. Funding through the 5310-grant program can be used to purchase vehicles, support operating costs, provide training for drivers, and develop transportation plans that address the specific needs of seniors and individuals with disabilities.

While Wichita Transit is the designated recipient of 5310 funding, WAMPO led the call for projects and grant selection process. The federal funding amount available for this year's Section 5310 program has funding from the Federal Fiscal Years (FFY) 2021 (\$436,945) and 2022 (\$640,199). The program timeline for this year's funding is July 1, 2023 - June 30, 2025.

WAMPO opened the call for projects on December 1st, 2022. It closed on February 28th, 2023. A workshop was held on December 8th, 2022. After the submission deadline, a selection committee comprised of three community members independently assessed each project's merits and assigned scores based on predefined criteria. These criteria included factors like a demonstration of need, addressing accessibility and/or collaboration goals, meeting specific needs of older adults/disabilities, and Coordinated Transit District #9-member status. The committee then met to discuss the projects and share their individual scores. This collaborative session allowed for a comprehensive evaluation and facilitated the selection process. By sharing their scores, the committee members could compare assessments, provide insights, and reach a consensus on the most promising projects.




