WHICH PROJECTS FROM THE FFY2021-FFY2024 TIP ARE NOT IN THE FFY2023-FFY2026 TIP?

Not all projects from the FFY2021-FFY2024 TIP have been carried forward into the FFY2023-FFY2026 TIP. There are 37 projects in the FFY2021-FFY2024 TIP whose lead agencies confirm have been completed, so there is no reason to continue to show them in the FFY2023-FFY2026 TIP. There are also 4 projects from the FFY2021-FFY2024 TIP that have not been started and whose lead agencies have decided to no longer pursue at this time, so those projects have been removed and are not incorporated into the FFY2023-FFY2026 TIP, either. These 41 projects are identified in the following tables.

It is common for TIP project details to be amended several times before the next adoption of a new TIP, sometimes including the removal of a project from the TIP.
