MTP 2050 Progress

The Metropolitan Transportation Plan (MTP) is a strategic, long-term document guiding future transportation projects in the WAMPO region. By federal mandate, Metropolitan Planning Organizations must involve the public throughout the planning process. The MTP 2050 must be completed by May 2025. WAMPO is in the process of conducting the call for projects and the second round of public engagement.

Round 2 Public Engagement Progress

WAMPO is in the second public engagement phase of the Metropolitan Transportation Plan 2050 (MTP 2050) process. The first round (05/13/2023 – 07/31/2023) provided insight into the transportation priorities for the region, aiding the development of the plan vision, goals, and objectives. This round (12/01/2023 – 02/29/2024) will build upon and clarify data gathered in the first round. Engagement efforts include a second MTP 2050 survey, a pin activity at tabling events, and general outreach to help increase WAMPO's presence in the community. To date, WAMPO has participated in 4 pop-up events, with more scheduled in 2024, to gather public input via the MTP 2050 Round 2 surveys. MTP/TIP Call for Projects

On September 15, 2023, WAMPO opened a combined Call for Projects for the long-range Metropolitan Transportation Plan 2050 (MTP 2050) and the short-range FFY2025-FFY2028 Transportation Improvement Program (TIP). Because



there is a single Call for Projects for both planning documents, jurisdictions that need to add or modify a project in both of them only need to submit a single application (any project that will use federal funding or be regionally significant must appear in the TIP, which must be consistent with the MTP). Jurisdictions are asked to submit their applications by January 5, 2024. The FFY2025-FFY2028 TIP is due to be approved by the WAMPO Transportation Policy Body (TPB) in August 2024 or earlier. MTP 2050 is due to be approved by the TPB in May 2025 or earlier.



Transportation Planning Updates

Electric Vehicle Network Plan Survey Results

The Electric Vehicle Network Plan survey results have been analyzed and staff has developed a report that can be found on our website at https://www.wampo.org/electric-vehicles. WAMPO staff is currently in the process of developing the Electric Vehicle Network Plan which is proposed to be open for public comment in early 2024.

Comprehensive Safety Action Plan Updates

The Comprehensive Safety Action Plan (CSAP) was crafted with meticulous attention to enhancing the safety of drivers, pedestrians, and cyclists within the region. Developed over a 10-month period, the CSAP was shaped with stakeholder participation and public input. This collaborative approach has been vital in customizing the plan to meet the unique needs and characteristics of WAMPO's transportation network. This December the CSAP was submitted for Transportation Policy Board approval and it was subsequently adopted. The CSAP not only aligns with the regional transportation objectives but also opens new opportunities for securing future safety-related infrastructure funding.

The adoption of a Comprehensive Safety Action Plan is a prerequisite for applying for a Safe Streets and Roads for All (SS4A) Implementation Grant. This federal grant is designed to support community initiatives aimed at curtailing transportation-related fatalities and serious injuries. This grant focuses on the execution of strategies within the CSAP that may involve major infrastructure improvements and could mark a significant step in reinforcing the region's commitment to creating safer, more secure streets for its residents. WAMPO intends to begin developing an SS4A Implementation Grant application over the course of the next year.

Safe Routes to School

The Safe Routes to School (SRTS) program aims to make walking and biking to school safer for students in the United States through infrastructure improvements, enforcement, tools, and safety education. Passionate about the goals of promoting safety, active transportation, and community engagement while reducing traffic congestion, WAMPO has worked to direct additional Transportation Alternatives (TA) funding for SRTS planning assistance in the region. In early 2024, WAMPO will reopen the application period for jurisdictions and schools/school districts who wish to receive help from WAMPO-hired consultants in the development of their SRTS plans. Once such plans are in place, the projects and activities called for in those plans (e.g., new crosswalks and sidewalks, safety-education programs) will be better positioned to take advantage of future funding opportunities.

Regional Transit Implementation Plan

WAMPO is collaborating with SRF Consulting Group, Nelson\Nygaard Consulting Associates, and Shockey Consulting Services to develop a Regional Transit Implementation Plan, building on the 2018 Wichita Area Transit Feasibility Study. The plan's deliverables include, among other things, a History of Transit, Feasibility and Future Conditions Reports, Steps to Establishing a Regional Transit Authority, and an Implementation Plan.



The Regional Transit Implementation Plan is currently undergoing its public engagement phase. WAMPO staff have been and will continue to participate in public events until February. The primary objective of this engagement phase is to gain a deeper understanding of public sentiments and perceptions regarding public transit in the region. An interactive dot activity is being employed at tabling events to facilitate this deeper understanding.

2023 Bike-Pedestrian Count Results

WAMPO conducts an annual count of bicycle and pedestrian activity from 38 different sites in the area, including in Park City, Goddard, Andover, Mulvane, Wichita, and other cities in the WAMPO region.

The data collected during the count help to estimate the number of people who bicycle, walk, and run, and the locations where they do so. Once collected, the data are used to plan the locations of future bicycle and pedestrian investments. To effectively gather this information, we rely on a team of volunteers to spend a short period of time at each site counting bicyclists and pedestrians.
