#### C. Director's Report

#### i. Safe routes to School Planning

Ashley Bryers provided an announcement on the Safe Routes to School (STRS) program. The SRTS program aims to make walking and biking to school safer for students in the United States. Established in 2005, under SAFETEA-LU, its goals are to promote safety, active transportation, and community engagement while reducing traffic congestion. WAMPO is actively planning and identifying stakeholders for successful program implementation, including infrastructure improvements, educational programs, and encouragement activities. The focus is on creating safer environments for students and promoting healthier lifestyles. On Friday, August 25, 2023, WAMPO staff sent an email to all member jurisdictions to clarify which ones are interested in being part of the process.

**Discussion:** Gary Janzen asked what WAMPO is looking for and what the planning effort will look like, including where the jurisdictions are with it, advance planning, and funding. Ms. Bryers explains that the schools and cities will work together to identify sidewalk gaps and create educational programs at the schools. It will also consist of working on the 6 Es: engineering, education, encouragement, evaluation, engagement, and equity. Once the jurisdiction has an SRTS plan, they can pursue SRTS TA funding to actually fill sidewalk gaps, make crosswalk improvements, and fund educational and encouragement programs. WAMPO is currently in the early stages of planning for what the SRTS effort will look like but needs to know who is interested in participating. Mr. Janzen asked if WAMPO has all the sidewalks mapped out; Ms. Bryers responded that WAMPO does have that available on its website. Brent Clark asked if this is a separate program from missing links. Ms. Bryers said she was unsure about the missing links program, but that SRTS funding comes from Transportation Alternatives funding WAMPO receives and comes down to how much the TPB will want to allocate for it.

#### i. Electric Vehicle Plan Survey and Process

Dora Gallo provided an update about the Electric Vehicle (EV) plan. The plan will outline the first steps the region can take to encourage electric vehicle adoption and gather feedback about how to improve the EV charging station infrastructure. WAMPO is currently in the public engagement phase, which consists of collecting surveys about the plan. WAMPO has collected 560 surveys. The survey is available at <a href="https://www.wampo.org/electric-vehicles">www.wampo.org/electric-vehicles</a> through August 31, 2023.

#### ii. Bike/Ped Count Volunteers Needed

Ms. Gallo requested volunteers to help with the annual Bicycle and Pedestrian (Bike/Ped) count. She also requested that the TAC members share information about the Bike/Ped count to help WAMPO recruit volunteers. #### iii. Notice of TIP Administrative Adjustments 3.15 & 3.16

Peter Mohr reported that in mid-July 2023, KDOT staff informed WAMPO staff of an opportunity to add up to \$5,000,000 of federal funding to FFY2023 projects. On July 25, 2023, the Project Selection Committee (PSC) met to decide how to use these funds in the limited time available before the end of FFY2023. Due to the short timeframe, not many projects could absorb the available funds. The PSC selected three projects to recommend for additional FFY2023 funding and these recommendations were enacted by Administrative Adjustments 3.15 and 3.16.

**Discussion:** Mike Armour asked if the August 2, 2023, date of Administrative Adjustment 3.16 was too late for the funding to obligate in FFY2023. Mr. Mohr explained that it was not, as the FTA-transfer project in Administrative Adjustment 3.15 had to be adjusted and sent to KDOT earlier than the FHWA-funded projects in Administrative Adjustment 3.16.

#### iv. FFY2023 TIP Projects Status Update

Mr. Mohr and Nick Flanders provided an update on FFY2023 TIP Projects Status. The WAMPO TIP Policy includes a Reasonable Progress Policy, under which projects receiving WAMPO suballocated funding in the current FFY or that received it in a past FFY but are not completed are to have bimonthly progress reports to the TAC/TPB. This is the progress report to the TAC for August 2023.

#### 4. Action

#### A. 2023 UPWP Amendment #3

Ms. Bryers explained that the TAC is asked to make a recommendation on proposed Amendment #3 to the 2023 Unified Planning Work Program (UPWP), which includes WAMPO's participation in the KDOT K-15 Corridor Management Plan, the City of Wichita's Reconnecting Communities Pilot grant for the 21st Street Corridor, addressing food-access concerns, and adjusting the anticipated expenditures and budget based on these efforts. The public comment period was August 9, 2023, through August 24, 2023. No comments have been received to date.

**Action:** Recommend the TPB approve the 2023 UPWP amendment #3, as presented (17-0).

#### 5. Discussion/Updates

#### A. MTP 2050 Survey Results

Ms. Bryers and Julian Pando gave an update on the first round of public engagement for Metropolitan Transportation Plan 2050 (MTP 2050), which ended on July 31, 2023, and included stakeholder meetings and a public survey. Data collected during this round of public engagement will help determine the vision, goals, and objectives of MTP 2050.

**Discussion:** Justin Shore asked if WAMPO broke down the results by age on all the results; WAMPO could provide that information. Gary Janzen asked if there was any clarification of what congestion was or was it all based on respondents' perceptions; WAMPO did not make those clarifications in the survey instructions. Mary Hunt asked how WAMPO did engagement with the Hispanic community; WAMPO staff looked for events they could attend and would welcomed to, and also talked to Empower. Alan Kailer commented that WAMPO did a great job in the public outreach efforts.

Chad Parasa commented that public engagement is part of the requirements for the long-range transportation plan. Chair Kessler appreciated WAMPO going to Haysville for National Night Out.

#### **B.** Coordinated Public Transit – Human Services Transportation Plan Survey Results

Ms. Bryers provided an update on the current process of updating the Coordinated Public Transit – Human Services Transportation Plan. As part of the plan development, WAMPO launched a public survey, available from June 16, 2023, through July 31, 2023. The survey was available in English, Spanish, and Vietnamese, both online and on paper. There was a total of 262 survey submissions, out of which 195 were on paper and 67 were completed online. Approximately 80-95 total staff hours were dedicated to promoting the public survey, including helping respondents fill it out. Survey findings were presented to the United Community Transit Coalition (UCTC) on August 17, 2023. Survey results were presented visually, using charts and/or frequency maps for each survey question.

**Discussion:** Mr. Parasa added that the regional transit implementation plan is in the process of development.

#### C. Commuter Flows Report

Mr. Mohr gave an update on the 2023 Commuter Flows Report, which describes how commuters flow between the 22 different municipalities in the WAMPO region. This report is compiled by WAMPO staff annually and has been updated with the most recent employment data from the U.S. Census Bureau.

**Discussion:** Ms. Hunt asked if the information presented was only for employment. Mr. Mohr confirmed that the information only showed employment trends. Mr. Kailer asked if we are able to see where people travel other than to work. Mr. Mohr said to retrieve that information WAMPO staff could use the travel demand model (TDM).

#### D. K-254 Corridor Report

Mr. Mohr, Mr. Parasa, and Dylan Cossaart gave an update that the Kansas Department of Transportation (KDOT) and the K-254 Corridor Development Association are developing a corridor management plan for K-254, between Wichita and El Dorado. For that corridor management plan, WAMPO staff developed a summary report of related data. The K-254 corridor extends from I-135 in Sedgwick County to eastern El Dorado in Butler County and represents a major thoroughfare for passengers and freight, both within and outside the WAMPO region. The

K-254 Corridor Development Association is made up of many key stakeholders in the K-254 corridor, including WAMPO.

**Discussion:** Brent Clark asked if the daily traffic data in the report include how many travel to the landfill in Butler County. Mr. Mohr responded that they do not.

Chair Kessler asked if WAMPO has data on the turnpike, since many people from El Dorado use it to come to Wichita. Mr. Mohr responded that WAMPO staff could compile some AADT data on that.

#### E. Intelligent Transportation Systems ITS Plan Update Process and Steering Committee

Mr. Mohr also updated that WAMPO is currently in the process of updating its Intelligent Transportation Systems (ITS) plan. ITS projects are funded through the highway trust fund and are required to conform to the National ITS Architecture and applicable standards. WAMPO staff is in the early stages of its ITS plan and is developing a steering committee and project timeline.

#### F. Social Media Report

Ms. Bryers updated that WAMPO has enhanced its digital marketing efforts to achieve specific public participation goals. WAMPO staff's aim is to ensure that the organization's digital marketing strategy aligns with WAMPO's public participation plan. Focusing on specific goals and objectives enhances WAMPO staff's ability to monitor key performance indicators and adapt the digital marketing strategy as needed. #### **Executive Summary**

The Safe Routes to School (SRTS) program aims to make walking and biking to school safer for students in the United States. Established in 2005, under SAFETEA-LU, its goals are to promote safety, active transportation, and community engagement while reducing traffic congestion. The focus is on creating safer environments for students and promoting healthier lifestyles. WAMPO will use \$200,000 of FFY2024 Transportation Alternatives (TA) funding to start providing SRTS planning assistance to member jurisdictions and their respective school districts. Jurisdictions and school districts were given until **5:00 PM on Friday, September 22, 2023**, to submit an application to <a href="mailto:srts@wampo.org">srts@wampo.org</a>.

#### **Background**

The Safe Routes to School (SRTS) program is a national initiative in the United States that aims to improve the safety and accessibility of walking and bicycle routes for students traveling to and from school. The program was established in 2005, under the federal transportation legislation known as Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU). The primary goals of the SRTS program are to promote safety, encourage active transportation, reduce traffic congestion, and create a sense of community. Safe Routes to School programs are typically implemented at the state and local levels, with federal funding allocated to individual states for distribution.

Key components of SRTS (the "6 Es"):

- » Engineering (i.e., infrastructure improvements)
- » Educational programs
- » Encouragement activities
- >> Engagement (replaced "Enforcement" in 2020)
- » Equity
- » Evaluation of successes and failures

By implementing Safe Routes to School programs, communities (in collaboration with school districts) can create safer environments for students, encourage healthier lifestyles, and contribute to the overall well-being of children and their communities.

#### **WAMPO's SRTS Program**

WAMPO is embarking on an extensive planning process to ensure the successful implementation of Safe Routes to School in the region. WAMPO will utilize \$200,000 of suballocated Federal Transportation Alternatives (TA) funding programmed for SRTS in FFY2024 to provide assistance to member jurisdictions and their respective school districts in the development of SRTS plans. Such plans may cover an entire school

district, city, or other jurisdiction, or they may be specific to one or more individual school buildings and their environs. Particular focus will be placed on elementary and middle schools, as opposed to high schools.

Several city and county governments in the WAMPO region have already expressed interest in developing SRTS plans with their respective school districts. Once such plans are in place, the activities called for in those plans become eligible uses of future TA funds. The window to apply for planning assistance opened on September 8, 2023.

#### **Next Steps**

- **>>** WAMPO member jurisdictions and their respective school districts have until **5:00 PM on Friday, September 22, 2023**, to fill out the SRTS planning-assistance application available at <a href="https://www.wampo.org/srts">https://www.wampo.org/srts</a> and submit it to <a href="mailto:srts@wampo.org">srts@wampo.org</a>.
- **»** If more jurisdictions/districts apply for planning assistance than can be accommodated with the amount of funding available for this initial round, WAMPO will apply evaluation criteria to determine which applicants to prioritize.
- » Once the first-round recipients of SRTS planning assistance have been determined, WAMPO will work with KDOT to program the funds. Following that, WAMPO will distribute a Request for Proposals (RFP) for a consulting firm to assist the selected local governments and school districts in the preparation of their SRTS plans. The TPB will need to approve the selected consultant.
- **»** Up to 80% of the cost of the consulting firm will be paid out of the \$200,000 of FFY2024 TA funds awarded to WAMPO for this project. WAMPO will invoice the selected local jurisdictions and/or school districts for the required 20% local match.
- **»** As part of the SRTS planning effort, school/district staff will be tasked with distributing a survey to parents of their students, conducting tallies of how students traveled to and from school on specific dates, and providing other anonymized data.
- » In future years, after the \$200,000 of FFY2024 TA funding has been exhausted, WAMPO staff will use knowledge of SRTS plan-development gained from the hired consultant to continue to provide SRTS planning assistance to those member jurisdictions and school districts that request it. However, the number of jurisdictions/districts that may receive such assistance in a given year will be limited by the availability of WAMPO staff.

#### **Executive Summary**

The Comprehensive Safety Action Plan (CSAP) will be available for public comment from September 19 through October 19, 2023. The TPB will consider the plan for approval at their November 14, 2023, meeting. This plan was developed through a 10-month process.

#### **Background**

The public comment period for the Wichita Area Metropolitan Planning Organization (WAMPO) Comprehensive Safety Action Plan (CSAP) (<a href="https://www.wampo.org/safety">https://www.wampo.org/safety</a>) will be open from September 19 through October 19, 2023. Public feedback is important to the success of the CSAP. Community members from across the Wichita region who walk, bicycle, ride scooters, drive, and use public transit or a mobility device are all invited to comment on the draft planning document. Such input will help refine solutions for safer roads, safer speeds, safer vehicles, post-crash care, equity, and creating a safety culture.

WAMPO and Wichita-region communities and public agencies have collaborated to develop the CSAP through a 10-month planning process. WAMPO staff and a consultant team have engaged the community; reviewed existing plans, policies, and projects; conducted data analyses; applied the U.S. Department of Transportation's Safe System Approach (<a href="https://www.transportation.gov/NRSS/SafeSystem">https://www.transportation.gov/NRSS/SafeSystem</a>); and recommended specific steps the region should take to improve transportation safety for everyone. WAMPO will leverage the final plan as the agency and its partners pursue funding for recommended improvements.

#### 2024 Unified Planning Work Program 30-Day Public Comment Period

#### **Executive Summary**

The 2024 Unified Planning Work Program (UPWP) is available for public comment from September 9 through October 9, 2023. The UPWP is WAMPO's primary budgeting document for planning activities in 2024. View the draft document at <a href="https://www.wampo.org/upwp">www.wampo.org/upwp</a>.

#### **Background**

The Wichita Area Metropolitan Planning Organization (WAMPO) has opened the public comment period for its 2024 Unified Planning Work Program (UPWP), September 9, 2023, through October 9, 2023. Public comments received during this period will be reported to and considered by the WAMPO Transportation Policy Body (TPB), which will decide whether to approve the 2024 UPWP at their November 14, 2023, meeting.

The UPWP is WAMPO's primary budgeting document for planning activities during the year (January 1-December 31). Funding for the UPWP comes from various sources, including federal Comprehensive Planning Grant (CPG) funds, which require a 20% local match (i.e., 80% Federal funding, 20% local funding). The CPG/local-match expenditures in the 2024 UPWP total \$2,189,850.

In 2024, WAMPO planning priorities and activities will include:

- >> Continuing to develop the 2050 Metropolitan Transportation Plan (Metropolitan Transportation Plan 2050 (MTP 2050)),
- **»** Administering the FFY2023-FFY2026 Transportation Improvement Program (TIP) and developing the FFY2025-FFY2028 TIP,
- » Completing the fiscally constrained Regional Transit Implementation Plan,
- Implementing the Comprehensive Safety Action Plan (CSAP) and developing ICT Safe: A Regional Transportation Coalition,
- » Updating the Economic Development Report,
- Developing the Regional Active Transportation Plan,
- » Conducting Safe Routes to School planning, and
- **»** Completing an update to the Intelligent Transportation Systems Architecture.

# Agenda Item 2Civ: Director's Report ICT Safe: A Regional Transportation Coalition

#### **Executive Summary**

The WAMPO Safety and Health Committee (SHC) is transitioning to a new body called ICT Safe: A Regional Transportation Coalition, through which WAMPO will assume responsibility for Drive Safe Sedgwick, which has been administered by KDOT up to now. Additionally, under the ICT Safe umbrella, KDOT and WAMPO will administer up to \$50,000 of Behavioral Safety Grants per year.

#### **Background**

The Kansas Department of Transportation (KDOT) Bureau of Transportation Safety requested that WAMPO take over the Drive Safe Sedgwick Coalition (up to now comprised of KDOT-affiliated agencies and contractors) and form a WAMPO regional safety coalition. Prior to that request, WAMPO had already been hosting quarterly Safety and Health Committee (SHC) meetings since 2020, with representatives from various jurisdictions in the region. Since WAMPO is wrapping up the development of its Comprehensive Safety Action Plan (CSAP), it is an opportune time to transition the SHC and Drive Safe Sedgwick into a regional safety coalition. The selected name for the coalition is ICT Safe: A Regional Transportation Coalition.

While Drive Safe Sedgwick will have a new home with WAMPO, it will retain its identity and its current focus on addressing impaired driving (this may change over time).

Among other activities under the ICT Safe umbrella, KDOT and WAMPO will administer up to \$50,000 of Behavioral Safety Grants per year, to help local jurisdictions and nonprofit organizations address transportation-related behavioral safety concerns. For the first round of funding, a call for projects will open in Spring 2024.

A combined Call for Projects for Metropolitan Transportation Plan 2050 (MTP 2050) and the FFY2025-FFY2028 Transportation Improvement Program (TIP) is open from September 15, 2023, through January 5, 2024.

#### **Background**

WAMPO is in the process of developing the next Metropolitan Transportation Plan (MTP) for the region, Metropolitan Transportation Plan 2050 (MTP 2050), due by June 2025, as well as the FFY2025-FFY2028 Transportation Improvement Program (TIP), due by August 2024. Both to save member jurisdictions the trouble of submitting two separate applications and to ensure consistency between MTP 2050 and the FFY2025-FFY2028 TIP, WAMPO staff opened a combined MTP/TIP Call for Projects on September 15, 2023, which will run through **January 5, 2024**. All member jurisdictions should have received a detailed application packet specifying all of the information they must provide in order for WAMPO to prioritize projects both for inclusion in the MTP and TIP and for receiving WAMPO-suballocated Federal funding. #### **Executive Summary**

The TAC is asked to make a recommendation to the TPB on proposed Amendment #5 to the WAMPO FFY2023-FFY2026 Transportation Improvement Program (TIP). Amendment #5 is a regularly scheduled TIP amendment and would maintain the fiscal constraint of the FFY2023-FFY2026 TIP. The Public Comment period for Amendment #5 opened on September 1, 2023, and ran through September 15, 2023. On September 8, 2023, during the Public Comment period, at the request of KDOT staff, updates were made to some of the projects in Amendment #5. No public comments have been received to date.

#### **Background**

Amendment #5 to the WAMPO FFY2023-FFY2026 Transportation Improvement Program (TIP) is a regularly scheduled amendment. It is the fifth scheduled amendment for this TIP, **adding ten (10) new projects** and **modifying four (4) projects**. The below-linked Amendment #5 summary also provides notice of **administrative adjustments to an additional six (6) projects**, which do not require approval by the TAC or TPB. The Public Comment period for Amendment #5 opened on September 1, 2023, and ran through September 15, 2023. On September 8, 2023, during the Public Comment period, at the request of KDOT staff, updates were made to some of the projects in Amendment #5. No public comments have been received to date. The FFY2023-FFY2026 TIP took effect on October 1, 2022, and may be found at <a href="https://www.wampo.org/transportation-improvement-program">www.wampo.org/transportation-improvement-program</a>. The TAC is now asked to provide its recommendation on the proposed project additions/modifications.

#### **Fiscal Considerations**

Federal regulations require that the TIP be "fiscally constrained," meaning that there are enough projected revenues to cover the costs of the projects listed in the TIP. After accounting for the proposed changes (see below table), the TIP is fiscally constrained for the period FFY2023-FFY2026.

#### **Coordinated Public Transit - Human Services Transportation Plan**

#### **Executive Summary**

The Coordinated Public Transit – Human Service Transportation Plan (CPT-HSTP) is a tool for the community to coordinate human services transportation programs for older adults, people with disabilities, and low-income households within the WAMPO region. The TAC is asked to make a recommendation to the TPB on whether or not to approve the draft plan.

#### **Background**

The Coordinated Public Transit – Human Services Transportation Plan (CPT-HSTP) focuses on the transportation options available to frequently underserved populations, including those over age 64, those with disabilities, and low-income households. Human services transportation includes a broad range of transportation service options designed to meet the needs of these populations.

Regardless of age, disability, or income level, people have various transportation needs, and an individual may require a specific set of services depending on their abilities, environment, and the options available in their community.

The CPT-HSTP is a tool for the community to coordinate human services transportation programs for older adults, people with disabilities, and low-income households within the WAMPO region.

The first CPT-HSTP was completed in 2010. It was updated in 2013, 2018, and 2023.

#### 2023 Plan Overview & Purpose

Section I of the draft CPT-HSTP provides background information.

Section II explores the assessment of local needs and includes the following:

- **Community Profile:** A description of the current system and target populations within the WAMPO region, as well as a listing of available services, current transportation providers (public, private, and nonprofit), and an overview of public transportation funding.
- **» Needs Assessment:** Description of the transportation needs of the target populations and gaps in service.

Section III defines the targeted approach and priorities identified and informed by public input:

**»** Implementation Plan: Identifies strategies, activities, and/or potential projects that could be used to address gaps or opportunities in service delivery. The implementation plan is based on available resources (from multiple program sources), time considerations, and the feasibility of the identified strategies/activities.

#### **Intelligent Transportation Systems Steering Committee**

#### **Executive Summary**

WAMPO is in the process of updating its Intelligent Transportation Systems (ITS) architecture document. ITS projects are funded through the highway trust fund and are required to conform to the National ITS Architecture and applicable standards. A project timeline has been developed and a list of proposed steering committee members has been assembled, on which the TAC is asked to make a recommendation to the TPB.

#### **Background**

The purpose of developing a regional Intelligent Transportation Systems (ITS) architecture is to illustrate and document how the Intelligent Transportation Systems of all relevant stakeholders (e.g., MPOs, municipalities, counties, emergency services, state DOTs) are integrated with one another. This ensures that planning and deployment can take place in an organized and coordinated fashion. Typically, a metropolitan region contains multiple transportation agencies and jurisdictions. Regional integration allows the sharing of information and coordination of activities among regional transportation systems to operate efficiently and effectively. ITS projects funded through the highway trust fund are required to conform to the National ITS Architecture and applicable standards. The intention of these federal regulations and policies is to foster the deployment of integrated regional ITS systems.

WAMPO staff are in the process of creating a Steering Committee and developing a project timeline for an updated regional ITS plan. A broad project timeline, with milestones and completion timeframes, has been developed (see attached). WAMPO's current internal timeline proposes forming the Steering Committee in October 2023 and presenting a final ITS plan to the TPB in April 2024. A proposed list of Steering Committee members has been compiled (see attached), on which the TAC is now asked to make a recommendation to the TPB.

#### **Regional Transit Implementation Plan Steering Committee**

#### **Executive Summary**

The TPB signed a contract with a consultant group on July 11, 2023, to develop a Regional Transit Implementation Plan. The Plan will include the history of transit in the WAMPO region, a regional transit feasibility report, a future conditions and scenarios report, steps for establishing a Regional Transit Authority, an implementation plan, and a task to develop and execute agreements between transit providers. The TAC is now asked to make a recommendation to the TPB on a proposed Steering Committee for the development of this plan.

#### **Background**

The TPB signed a contract with SRF Consulting Group, Inc., with sub-consultants Nelson\Nygaard Consulting Associates, Inc. and Shockey Consulting Services, LLC, on July 11, 2023, to develop a Regional Transit Implementation Plan.


The plan will build upon Connecting Communities: Wichita Area Transit Feasibility Study (2018) and will be a companion plan to the Wichita Transit Network System Redesign Study and the Coordinated Public Transit - Human Services Transportation Plan.

The planning process includes the following deliverables:

- >> History of Transit in the WAMPO Region
- » Regional Transit Feasibility Report
- >> Future Conditions and Scenarios Report
- Steps to Establishing a Regional Transit Authority
- >> Implementation Plan
- Development of and Executing the Plan/Agreement between Transit Providers

#### **Steering Committee**

The United Community Transit Coalition (UCTC) is proposed to serve as the basis for the Steering Committee for the Regional Transit Implementation Plan (see Table 1). However, as public transit is a workforce issue, additional entities that haven't traditionally been involved in transit planning are also proposed to be included.

#### **Executive Summary**

WAMPO is developing an Electric Vehicle (EV) Plan for the region. The public-engagement phase of plan development has concluded; it involved a public survey to help WAMPO understand needs and identify potential goals and strategies for the plan. There are currently 23 EV charging stations in the region.

#### **Background**

The WAMPO Electric Vehicle Plan will outline the first steps the region can take to support and encourage electric-vehicle (EV) adoption, deliver a comprehensive course of action to provide EV charging infrastructure, and remove barriers to further efficient and effective EV adoption in the WAMPO region. This plan will serve as a starting point for private and public entities to grow more familiar with opportunities and challenges related to electric vehicles, charging infrastructure, and the adoption thereof.

The Electric Vehicle Plan will support Metropolitan Transportation Plan 2050 (MTP 2050) and the Charge Up Kansas National Electric Vehicle Infrastructure (NEVI) Plan by advancing the use of EVs to improve air quality and foster economic development. WAMPO has an opportunity to adapt to emerging technologies by closing EV-charging infrastructure gaps and removing barriers to EV adoption.

#### Survey

As part of the plan development, WAMPO conducted a public survey. The survey responses helped WAMPO understand needs and identify potential goals and strategies for the plan. The survey was available in English, Spanish, and Vietnamese, both on the WAMPO website (<a href="www.wampo.org/electric-vehicles">www.wampo.org/electric-vehicles</a>) and on paper forms made available at various public events. The survey opened on June 25, 2023, and closed on August 31, 2023. There was a total of 577 online and paper surveys collected.

#### **Existing Conditions**

Electric vehicle ownership is growing in the WAMPO region. According to the Kansas Department of Revenue (KDOR), as of April 30, 2023, there are 117 all-electric vehicles, 17 electric hybrid vehicles, 499 hybrid vehicles, and 11 electric plug-in hybrid vehicles registered in Butler County (including the parts of the county that are outside the WAMPO region). As of the same date, Sedgewick County has 952 all-electric vehicles, 714 electric hybrid vehicles, 2,942 hybrid vehicles, and 147 electric plug-in hybrid vehicles registered. Meanwhile, Sumner County has 10 electric vehicles, 5 electric hybrid vehicles, 75 hybrid vehicles, and 3 electric plug-in hybrid vehicles registered.

As of September 11, 2023, there 14 free EV charging stations in the WAMPO region. Overall, there are 23 EV charging stations in the region, counting both free stations and those that require payment.

# Agenda Item 5B: Discussion/Updates Urban Area Boundary Discussion

#### **Executive Summary**

Every ten years, MPOs need to adopt an Urban Area Boundary (UAB) that encompasses the corresponding Census Urban Area resulting from the latest decennial U.S. Census. There are a few locations where the 2020 Wichita Census Urban Area is not entirely within the current WAMPO UAB, meaning the WAMPO UAB needs to be updated. WAMPO staff, in consultation with KDOT staff, have developed a proposed new UAB. Before this proposed UAB is brought before the TAC for an official recommendation to the TPB, the TAC is asked at this time to discuss the proposed UAB and any changes that ought to be made to it.

#### **Background**

Within the Metropolitan Planning Area (MPA) of every Metropolitan Planning Organization (MPO) is an Urban Area Boundary (UAB), distinguishing between urban and rural portions of the MPA, either as they currently are or as they are expected to soon be. Within the UAB, roads with a Federal Functional Classification (FFC) of "minor collector" are eligible for Federal Surface Transportation Block Grant (STBG) funding, whereas rural minor collectors (outside the UAB) are not. Meanwhile, if the MPO serves an urbanized area of more than 200,000 people and therefore qualifies as a Transportation Management Area (TMA), as the WAMPO region does, pedestrian and bicycle projects in any part of the MPA may qualify for Federal Transportation Alternatives (TA) funding suballocated to the MPO to award to projects, but projects in the non-UAB portion of the MPA may also qualify for non-suballocated TA funds awarded by the state government.

Every ten years, following the decennial U.S. Census, new Census Urban Areas are established and existing ones have their borders adjusted. Under Federal law, an MPO's UAB must entirely contain the corresponding Census Urban Area in its entirety. For that reason, UABs also go through a decennial update process. After the Census Urban Areas are updated, MPOs and their respective state DOTs must agree on a UAB that meets all Federal requirements and submit it to the FHWA. If no UAB is submitted to the FHWA by the deadline (see below), the MPO's UAB will default to having the exact same extent as the corresponding Census Urban Area.

The 2020 Wichita Census Urban Area is mostly contained by the current WAMPO UAB (which was last adjusted in 2015), but there are a few locations where the 2020 Census Urban Area extends beyond the current UAB, meaning there is not an option to keep the current UAB, without alteration. Therefore, WAMPO staff have drafted a proposed new UAB and consulted with KDOT staff on its appropriateness. Before this proposed UAB is brought before the TAC for an official recommendation to the TPB, the TAC is asked at this time to discuss the proposed UAB and any changes that ought to be made to it.

#### **How the Proposed UAB Was Prepared**


- » Overlayed the current UAB with the 2020 Census Urban Area, to meet the Federal requirement that the UAB entirely contain the Census Urban Area
- » To meet the Federal guidance that the UAB "should" contain entire municipalities, overlayed the city limits of the 12 municipalities that are either partially or entirely within the current UAB or the 2020 Census Urban Area (Andover, Bel Aire, Derby, Eastborough, Goddard, Haysville, Kechi, Maize, Mulvane, Park City, Valley Center, Wichita)
  - Excluded one enclave of Wichita (in far southwest Sedgwick County) and one enclave of Mulvane (around the Kansas Star Casino) that are both far removed from the rest of the city or the urbanized area
- » Filled in any "holes" (i.e., reverse enclaves) in the resulting shape
- » Where the shape consisted of noncontiguous (but nearby) parts, connected them
- **>>** Extended the shape farther outward in some locations to make it more conducive to the eventual generation of the Federally required "metes and bounds" description that non-technical people can follow in the field.
  - With a few small exceptions, mostly prioritized roadways, railroad tracks, and waterways for boundaries
  - In two small instances, retracted the bounds of the proposed UAB to within the bounds of the current UAB, in the interest of reaching better metes-and-bounds borders (after confirming that the proposed UAB still would not exclude any part of the 2020 Census Urban Area or any of the city limits that were chosen for inclusion and that the land to be excluded from the UAB did not appear to be developed)
- **»** Confirmed that the proposed UAB is still entirely within the WAMPO Planning Area Boundary, as required by Federal law

#### **Next Steps**

- **»** WAMPO staff, with input from KDOT staff, will adjust the proposed UAB in response to the discussion at the September 25, 2023, TAC meeting
- » October 23, 2023: TAC makes recommendation to TPB on proposed UAB
- » November 14, 2023: TPB vote on approval of UAB
- » December 1, 2023: Deadline for MPOs to submit UABs to KDOT for review
- » December 29, 2023: Deadline for KDOT to submit final UABs to the FHWA

#### **Executive Summary**

WAMPO's 2023 Title VI Report was submitted to KDOT for approval on September 1, 2023, and demonstrates WAMPO's efforts to create and maintain a transparent and inclusive planning process by intentionally integrating Title VI, Environmental Justice (EJ), and Limited English Proficiency (LEP) principles into the WAMPO transportation planning process and intentionally reaching out to traditionally underserved populations in the WAMPO region. To date, no Title VI complaints have ever been received by WAMPO.

#### Background

It is the policy of WAMPO to ensure full compliance with Title VI of the Civil Rights Act of 1964, the Civil Rights Restoration Act of 1987, Executive Order 12898 on Environmental Justice (EJ), Executive Order 13166 on Limited English Proficiency (LEP), and related statutes and regulations in all programs and activities regardless of funding source. WAMPO's Title VI Report demonstrates WAMPO's efforts to create and maintain a transparent and inclusive planning process by intentionally integrating Title VI, EJ, and LEP principles into the WAMPO transportation planning process and intentionally reaching out to traditionally underserved populations in the WAMPO region.

Title VI, 42 U.S.C. § 2000d et seq., was enacted as part of the landmark Civil Rights Act of 1964. It prohibits discrimination on the basis of race, color, and national origin in programs and activities receiving federal financial assistance. WAMPO's Title VI program includes administrative/oversight activities, regional demographic analysis, the consideration of board/committee demographic makeups, and planning/programming activities, per federal requirements.

The WAMPO Title VI Report, the Title VI Discrimination Complaint Form, and LEP Plan are available on the WAMPO website (<a href="https://www.wampo.org/title-vi">https://www.wampo.org/title-vi</a>) in English, Spanish, and Vietnamese to ensure complete transparency. The Title VI Report is updated annually. To date, no Title VI complaints have ever been received by WAMPO.

#### **Executive Summary**




