# APPX A

## Planning Process

This planning process began in the fall of 2022 and concluded with the TPB approval of the MTP on **May 13, 2025**. The formation of the Plan Advisory Committee (PAC) was discussed with the TAC and TPB, as well as past members of the PAC to receive any input on potential improvements to the PAC. The PAC was formally approved by the TPB on December 13, 2022. The PAC met **five (5)** times over the course of the planning process.
