#### C. Director's Report

#### i. Quarterly UPWP Task Chart

Markey Jonas, WAMPO, shared that the Unified Planning Work Program (UPWP) is the primary budgeting document for planning activities in the calendar year and presented WAMPO's priority projects in the 2024 UPWP as well as the status of each priority project. WAMPO staff completed a UPWP activity report for the third quarter of 2024 (July 1-September 30) to submit as part of WAMPO's quarterly reimbursement package to KDOT.

#### ii. 2025 Unified Planning Work Program (UPWP) Public Comment Period

Ms. Jonas announced that WAMPO opened the public comment period for its 2025 Unified Planning Work Program (UPWP), September 9, 2024, through October 8, 2024. Public comments received during this period will be reported to and considered by the WAMPO Transportation Policy Body (TPB), which will decide whether to approve the 2025 UPWP at their November 12, 2024, meeting. Funding for the UPWP comes from various sources, including federal Consolidated Planning Grant (CPG) funds, which require a 20% local match (i.e., 80% federal funding, 20% local funding). The CPG/local-match expenditures in the 2025 UPWP total \$2,786,495. #### iii. Kansas Mobility Week, 11/03/2024-11/09/2024

Jessica Warren, Coordinated Transit District (CTD) #9, shared that Kansas Mobility Week is November 3 through November 9, 2024. Kansas Mobility Week is a celebration of making smart, efficient, and safe multimodal public transportation choices. This is the fourth year of the event. In 2023, there were 57 events across 38 counties in Kansas, along with two statewide events. Common activities include free rides and passenger-appreciation events. #### iv. Annual Bicycle and Pedestrian Count: Thank You to Volunteers

Kim Negrete, WAMPO, explained that every year, WAMPO coordinates an annual count of bicycle and pedestrian activity across the region. The data collected during this count help to estimate the number of people who bicycle, walk, and run, and the locations where they do so. The 2024 dates and times were Wednesday, September 11, 10:00 AM-12:00 PM and/or 5:00 PM-7:00 PM; Thursday, September 12, 10:00 AM-12:00 PM and/or 5:00 PM-7:00 PM; and Saturday, September 14, 12:00 PM-2:00 PM. Ms. Negrete thanked everyone who volunteered to help WAMPO gather data by spending a short period of time counting pedestrians and bicycle riders at designated locations.

Dora Gallo, WAMPO, shared that the bicycle/pedestrian-count data report and Annual Average Daily Traffic (AADT) projections for the year are in development and staff hope to have a draft report ready soon.

#### **Discussion:**

Chair Tuttle asked how the automatic bicycle and pedestrian counters that WAMPO is acquiring will affect the manual count in the future and how the count data will be used.

Ms. Negrete explained that WAMPO plans on using the automatic counters in conjunction with volunteers, at least for the first year or two, to verify count accuracy. The automatic counters may also be used to collect data outside of the annual count window or at alternate locations. Count data are used to see where people use active-transportation infrastructure most, and volunteer feedback helps signal where future safety improvements may be needed. These data are also often used by local jurisdictions, nonprofits, and advocacy organizations to document trends and enhance grant applications.

#### v. Regional Transit Implementation Plan Employer Focus Group Meeting, 09/16/2024

Chad Parasa, WAMPO, shared that there was an employer focus group meeting for the Regional Transit Implementation Plan, hosted in coordination with the consultant on the project, the Wichita Workforce Alliance, and WAMPO staff, on Monday, September 16, 2024. At the meeting, the project team introduced major employers in the region to the plan and the transit service alternatives and began further discussions about employer engagement.

#### vi. Metropolitan Transportation Plan 2050 (MTP 2050) Update

Nick Flanders, WAMPO, shared that WAMPO is developing long-range Metropolitan Transportation Plan 2050 (MTP 2050), which will guide the region's transportation infrastructure investments and policies over the next quarter century. The Project Selection Committee (PSC) met on October 3, 2024, to recommend projects for the MTP 2050 project list. As WAMPO works towards completing a draft of the full plan, draft chapters and appendices are being posted on the WAMPO website for public review. Upcoming steps include a Plan Advisory Committee (PAC) meeting on October 24, 2024.

#### 3. Public Comments

There were no public comments.

#### 4. Action

#### A. FFY2025-FFY2028 Transportation Improvement Program Amendment #2

Peter Mohr, WAMPO, asked the TPB to take action on proposed Amendment #2 to the WAMPO FFY2025-FFY2028 Transportation Improvement Program (TIP). Amendment #2 is a regularly scheduled TIP amendment and would maintain the fiscal constraint of the FFY2025-FFY2028 TIP.

The Public Comment period for Amendment #2 opened on August 30, 2024, and ran through September 13, 2024. No public comments were received. TIP Amendment #2 adds six (6) new projects, removes two (2) projects and modifies one (1) project. There were administrative adjustments to four (4) additional projects, which do not require approval.

Mr. Mohr listed the projects modified/added/removed, discussed the changes in local, state, and federal funding, and explained the federal requirements met by TIP Amendment #2: it is consistent with the current Metropolitan Transportation Plan, *REIMAGINED* MOVE 2040, and is fiscally constrained. The financial impact is an additional cost of \$27.1 million. Following approval by the TPB, the amendment will be sent to the Kansas Department of Transportation (KDOT) to be included in the State Transportation Improvement Program (STIP) for review and consideration by the Federal Highway Administration (FHWA) and the Federal Transit Administration (FTA). Federal approval is expected in November 2024.

#### **B. Support KDOT Federal Performance Measures**

Mr. Mohr explained that the Federal Highway Administration (FHWA) and Federal Transit Administration (FTA) jointly issued a Planning Rule that establishes various performance measures (PMs) to assess roadway safety (PM1), pavement and bridge condition (PM2), system performance and freight movement (PM3), transit asset management (TAM), and transit safety. Metropolitan Planning Organizations (MPOs) are required to either set their own targets or support the targets set by their respective state DOTs. In 2023, WAMPO chose to support KDOT in achieving its federal performance-measure targets. Mr. Mohr shared the 2024 KDOT targets and asked the TPB to vote on whether to continue to support KDOT's federal performance measure targets in 2024.

#### **Discussion:**

Jim Benage asked when performance-measure data from 2023 will be shared. Mr. Mohr explained that, as of now, on the federal-performance-measure dashboard on the KDOT website, the most recent data are from 2022, but are five-year rolling averages. The official numbers for the 2023 performance measures have not yet been released.

#### 5. Discussion/Updates

#### A. Annual Title VI Report

Ms. Jonas shared that WAMPO's 2024 Title VI Report was completed, submitted to KDOT, and uploaded to the WAMPO website on September 3, 2024. Title VI is part of the Civil Rights Act of 1964 and prohibits discrimination on the basis of race, color, and national origin in programs and activities receiving federal financial assistance. WAMPO ensures full compliance with Title VI, the Civil Rights Restoration Act of 1987, Executive Order 12898 on Environmental Justice (EJ), Executive Order 13166 on Limited English Proficiency (LEP), and related statutes and regulations in all programs and activities. The WAMPO Title VI Program Manual, Title VI Discrimination Complaint Form, Limited English Proficiency (LEP) Plan, and other resources are available on the WAMPO website in English, Spanish, and Vietnamese. To date, no Title VI complaints have ever been received by WAMPO.

#### **Discussion:**

Chair Tuttle asked if there was anything from the 2024 Title VI Report to highlight. Ms. Jonas shared that the annual report serves to outline any updates from the year (none in 2024) and to document compliance with all Civil Rights-related statutes and regulations. The annual report demonstrates WAMPO's efforts to create and maintain a transparent and inclusive planning process by intentionally integrating Title VI, EJ, and LEP principles into the transportation planning process. WAMPO will update its Title VI Program Manual and LEP plan in 2025.

#### B. Intelligent Transportation Systems (ITS) Architecture

Lonnie Burklund, JEO, shared that WAMPO has begun the process of updating the regional Intelligent Transportation Systems (ITS) Architecture, with consulting firm JEO and subcontractor TranSystems. Per federal guidelines, the regional ITS Architecture should be updated every 5 years. The last full ITS Architecture update was completed in 2006. The purpose of developing a regional ITS architecture is to document ITS infrastructure, devices, personnel, and maintainers, so that planning, deployment, and communication can take place in an organized and coordinated fashion. Without such a unified framework, opportunities for improving efficiency, safety, and data-sharing may be lost; at the extreme, a region could risk deploying incompatible or redundant technologies. The ITS Architecture development will involve engaging stakeholders through steering committee meetings and stakeholder workshops to gather input and ensure the project meets the needs of the WAMPO region. The project is expected to be completed in early 2024.

#### C. K-254 Access Management Plan

J.B. Wilson, KDOT, explained that KDOT is developing a corridor management plan for K-254 in Sedgwick and Butler counties. The plan covers 22 miles of K-254 from Wichita on the west to El Dorado on the east and the area within 1 mile of the highway. The presentation provided an overview of the K-254 Access Management Plan, a summary of the project-development process,

significant findings, and next steps. The goal of the corridor management plan is to anticipate future land development and establish an access-management approach that serves the communities while keeping traffic moving efficiently and safely. Next steps include a public meeting on October 9, 2024, to present the final plan. #### **Discussion:**

Mr. Benage shared appreciation for the work being completed for the K-254 corridor management plan, on behalf of the City of Bel Aire and the K-254 Corridor Development Association.

#### 6. Committee & Partnership Updates

Chair Tuttle announced that the next Executive Committee meeting will be at 11:00 AM on November 14, 2024, in the MAPD Conference Room in the Ronald Reagan Building (271 W 3<sup>rd</sup> St. N, Room 237, Wichita, KS 67202) and on Zoom. It will be an open meeting; anyone is welcome to attend.

Mike Moriarty, KDOT, provided an update on the K-96 and East Kellogg expansion projects, sharing that based on cost estimates for these projects and the remaining budget, it is getting increasingly difficult for KDOT to see the possibility of completing these projects under the Eisenhower Legacy Transportation (IKE) program. KDOT is reviewing options for funding these projects, but for the moment, the projects may be less feasible in coming years than originally hoped. Mr. Moriarty explained that it is not that money is being diverted from the WAMPO region, but rather that there is a funding gap, and that this news should not influence other projects in the region.

J.B. Wilson, KDOT Wichita Metro, shared construction updates in the WAMPO region.

#### 7. Other Business

Chair Tuttle announced that the City of Wichita will hold a groundbreaking ceremony for the City's future multimodal facility, The Hub, on Friday, October 11, 2024, at 9:00 AM. The event will be held on the lot at the corner of S Sycamore St. and W Texas Ave. A ceremonial groundbreaking will take place after remarks from City officials and the Regional Federal Transit Administrator.

#### **Executive Summary**

The WAMPO TIP Policy includes a Reasonable Progress Policy, under which projects receiving WAMPO-suballocated funding in the current FFY or that received it in a past FFY but are not completed are to have bimonthly progress reports to the TAC/TPB. This is the progress report to the TPB for November 2024.

#### **Background**

Page 16 of the WAMPO Transportation Improvement Program (TIP) Policy (Appendix I of the FFY2025-FFY2028 TIP - <a href="https://bit.ly/Appendix-i-TIP-Policy">https://bit.ly/Appendix-i-TIP-Policy</a>) establishes a Reasonable Progress Policy. This policy states that projects programmed to receive WAMPO-suballocated funding that are scheduled to start in the current Federal Fiscal Year (FFY) or that have started but not finished (including projects that started in prior FFYs) are supposed to have progress reports to the TAC and TPB at least every two months. The attached project statuses have been reported for the November 2024 bimonthly report to the TPB.

The Reasonable Progress Policy was revised by the Transportation Policy Body on April 11, 2023, but these bimonthly progress reports were kept as part of it.


# Transportation Improvement Program Current Suballocated Projects



#### **Executive Summary**

WAMPO's annual bicycle and pedestrian counts, conducted since 2012, offer crucial insights into nonmotorized travel trends in the region. The data help inform road improvements and nonmotorized transportation projects. They enhance public understanding of commuting, physical activity, and transportation interactions. Data collected at 36 locations in 2024 are used to project the Annual Average Daily Traffic (AADT) of bicycle riders and pedestrians in the region, based on national standards. WAMPO staff have compiled data, performed projections, and analyzed demographics to form a comprehensive report, and have developed a corresponding interactive map.

#### **Background**

Since 2012, WAMPO has conducted annual bicycle and pedestrian counts at various locations throughout the region, measuring nonmotorized travel. This helps to determine long-term walking and bicycling trends, as well as where emphasis should be placed by member jurisdictions in terms of road improvements, repairs, and new nonmotorized transportation projects. The results are shared with the public and government agencies and can help communities develop a more thorough understanding of how the WAMPO region commutes, stays active, and interacts with the transportation system. They also shed light on the relationships between transportation, land use, and climate by illustrating trends in road and path usage.

#### **WAMPO Bicycle and Pedestrian Count Projections**

From 2012 to 2022, bicycle riders and pedestrians were counted at 42 locations. The count locations were adjusted in 2023, and some removed, resulting in 35 designated count locations. In 2024, a new count location was added in Bel Aire, for a total of 36 count locations. Counts were conducted at each location for two hours on a Wednesday or Thursday morning, two hours on a Wednesday or Thursday evening, and two hours on a Saturday afternoon, for a total of six hours of volunteer time per count location. Data were gathered at both screenlines (a line that runs along a path or road, crossings of which are counted) and intersections (where passage through the intersection is counted, by direction of approach). WAMPO had support from approximately 60 community volunteers this year to collect these data.

Since 2022, WAMPO has used these counts to make projections representing larger swaths of time and traffic. Such projections can be used to predict and analyze daily, weekly, monthly, and yearly volumes and averages. The methodology for the counts follows national standards from the National Bicycle and Pedestrian Documentation Project. This methodology allows planners to calculate the Annual Average Daily Traffic (AADT) of bicycle riders and pedestrians.

In addition to static charts and maps of the results of the 2024 bicycle and pedestrian count projections, WAMPO is developing an online, interactive map that will be publicly accessible through the WAMPO website. The interactive map will include past count data and current projections. All bicycle and pedestrian count data, analysis, and projections are compiled in a comprehensive report, the WAMPO Bicycle and Pedestrian Projections Data Report 2012-2024, linked below.



#### **Executive Summary**

The Federal Transit Administration's (FTA's) Enhanced Mobility of Seniors and Individuals with Disabilities Program, also known as the Section 5310 Program, provides funding to support the transportation needs of older adults and individuals with disabilities. The program aims to reduce transportation barriers and enhance mobility for these populations through funding allocated to states, local transit organizations, and nonprofits. The Wichita Area Metropolitan Planning Organization (WAMPO) will be accepting applications for this competitive grant program, inviting eligible organizations to apply for funding to improve transit accessibility, safety, and inclusion for seniors and individuals with disabilities in the region.

#### **Background**

The Federal Transit Administration (FTA) Section 5310 Enhanced Mobility of Seniors and Individuals with Disabilities Program (Section 5310 Program), established under the Federal Transit Act, aims to address the mobility needs of the aging population and individuals with disabilities by enhancing transportation options, supporting service expansion, and ensuring accessibility. The program provides funding to transit agencies, nonprofit organizations, and other eligible entities to create innovative solutions and projects that improve the quality and availability of accessible transportation services. Projects may include vehicle purchases, operating costs, and technology upgrades, all designed to promote independence and reduce isolation among older adults and people with disabilities.

In the Wichita metropolitan area, WAMPO plays a vital role in administering this competitive funding program by overseeing the application and selection process, managing allocated funds, and providing guidance and resources for applicants. The program's goals align with WAMPO's mission to enhance the transportation network and promote a safer, more accessible, and equitable transit system for all users.

#### **FTA Section 5310 Program**

The Section 5310 Program is structured to enhance the mobility of seniors and individuals with disabilities by funding transportation-related capital and operating projects. Examples of eligible projects include:

- **» Vehicle Purchases and Equipment:** Funding may be used to acquire vehicles equipped with necessary accessibility features, such as wheelchair lifts, to support paratransit services. This aspect is especially beneficial for nonprofit organizations and local transit providers working to expand their fleets or replace aging vehicles.
- **» Operating Costs:** The Section 5310 Program supports operational expenses related to transportation services that meet the needs of the target populations. These costs may cover driver salaries, maintenance, fuel, and other necessary operating expenses that help sustain essential mobility services.
- **>> Transit Infrastructure:** Funds can be directed toward the development or improvement of transit facilities and infrastructure, such as ADA-compliant bus stops, shelters, and other physical upgrades to promote accessibility.
- **» Mobility Management:** The program encourages the implementation of management systems that coordinate transportation services across various providers, increasing efficiency and reducing

redundancy. Mobility management promotes more seamless, user-friendly transit options, ensuring people with disabilities and seniors can access transportation without unnecessary delays or complications.

**» Community-Based Services and Programs:** The Section 5310 Program supports community-oriented initiatives, such as travel training, volunteer driver programs, and transit information dissemination to help seniors and individuals with disabilities navigate the transportation system confidently.

In administering the FTA Section 5310 Program, WAMPO coordinates with local agencies to ensure an efficient selection process that addresses regional mobility needs. A selection committee reviews all applications based on factors such as project feasibility, cost-effectiveness, alignment with community needs, and potential to improve accessibility. WAMPO ensures a fair distribution of funds while maintaining compliance with federal guidelines and program requirements.

WAMPO's upcoming call for applications will provide an opportunity for local organizations to obtain funding for essential projects that enhance the mobility and independence of seniors and individuals with disabilities in the Wichita area. Eligible applicants are encouraged to submit project proposals for review, emphasizing initiatives that align with WAMPO's strategic transportation goals and the program's mission.

#### **Executive Summary**

The TPB is asked to take action on a proposed contract for on-call legal services between the Wichita Area Metropolitan Planning Organization (WAMPO) and Hite, Fanning & Honeyman, L.L.P., for the period of January 1, 2025, to December 31, 2027, for an amount not to exceed \$60,000.

#### **Background**

The Wichita Area Metropolitan Planning Organization (WAMPO) has received legal counsel and services through an on-call legal services law firm, Hite, Fanning & Honeyman L.L.P., Attorney Kelly Rundell. That contract, which was for three years starting January 1, 2022, is set to end on December 31, 2024.

WAMPO issued a Request for Proposals (RFP) for 2025-2027 On-Call Legal Services, which was open from September 13, 2024, through October 4, 2024. In response to this RFP, WAMPO received a proposal from one law firm, Hite, Fanning & Honeyman, L.L.P. Because no other consultants submitted proposals, a selection committee was not convened. Instead, WAMPO staff reviewed the submitted proposal, determined that it met the requirements outlined in the RFP, and decided to recommend Hite, Fanning & Honeyman, L.L.P. to provide on-call legal services.

If the TPB approves the contract, Hite, Fanning & Honeyman, L.L.P. will perform the services described in the attached proposed contract from January 1, 2025, through December 31, 2027.

#### **Fiscal Considerations**

The project will be on a fixed fee basis not to exceed \$60,000 and no more than \$20,000 per calendar year, as budgeted in the WAMPO United Planning Work Program (UPWP).

The standard cost for legal services (such as those included in the scope of services and not including litigation) will be \$185.00 per hour of attorney time for Evan Hathaway and \$210.00 per hour of attorney time for Kelly Rundell. There is no anticipation of needing paralegal or legal assistant services, however, if used with WAMPO's prior approval, their time would be charged at a rate of \$145.00 per hour.

#### Safe Routes to School (SRTS) Planning Assistance Contract

#### **Executive Summary**

The TPB is asked to take action on a proposed contract for regional Safe Routes to School Planning assistance between the Wichita Area Metropolitan Planning Organization (WAMPO) and SRF Consulting Group, Inc., during the period of November 2024-December 2026, for an amount not to exceed \$500,000.

#### **Background**

The Safe Routes to School (SRTS) program is a national initiative in the United States that aims to improve the safety and accessibility of walking and bicycle routes for students traveling to and from K-12 schools. The program was established in 2005, under the federal transportation legislation known as Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU). The primary goals of the SRTS program are to promote safety, encourage active transportation, reduce traffic congestion, and create a sense of community. SRTS programs are typically implemented at the state and local levels, in cooperation with schools and school districts.

WAMPO is embarking on an extensive planning process to ensure the successful implementation of Safe Routes to School in the region. WAMPO will partner with consultants to provide assistance to member jurisdictions, their respective school districts, and private schools in the development of SRTS plans. Several city and county governments in the WAMPO region and their respective school districts have already expressed interest in developing SRTS plans.

WAMPO issued a Request for Proposals (RFP) from May 31, 2024, through June 28, 2024, to hire a consulting firm to assist with the development of SRTS plans. Two proposals were received. A consultant selection committee was convened and the consultants who submitted proposals were interviewed. After diligent consideration of both proposals, the selection committee chose SRF Consulting Group, Inc. and a contract was developed.

If the TPB approves the contract, SRF Consulting Group will perform the services described in the attached, proposed contract during the period of November 2024 through December 2026, for an amount not to exceed \$500,000.

#### FTA Section 5310 Program Memorandum of Understanding

#### **Executive Summary**

The Federal Transit Administration (FTA) Section 5310 Program Memorandum of Understanding (MOU) outlines the collaboration framework between WAMPO and partner agencies to improve mobility services for seniors and individuals with disabilities. This MOU formalizes the responsibilities, processes, and commitments of each participating entity under the Section 5310 Program, ensuring clear guidelines for the allocation and use of funds, project management, and compliance with federal requirements. Through this MOU, WAMPO and partner agencies would commit to enhancing transit services that prioritize accessibility, safety, and the independence of vulnerable populations in the Wichita region. WAMPO staff recommend that the Transportation Policy Body (TPB) approve the MOU between Wichita Transit and WAMPO.

#### **Background**

The Federal Transit Administration's (FTA's) Enhanced Mobility of Seniors and Individuals with Disabilities Program, or Section 5310 Program, provides financial assistance to improve transportation options for seniors and individuals with disabilities. These funds are allocated through a competitive grant process, where paratransit providers submit applications to receive funding. This program is crucial in reducing barriers to essential services, promoting equitable access, and supporting independent living.

WAMPO, as a designated recipient of Section 5310 funds in the Wichita metropolitan area, collaborates with local governments, nonprofit organizations, and transit agencies to implement projects that meet the transportation needs of these populations. The FTA Section 5310 Memorandum of Understanding (MOU) serves as a formal agreement between WAMPO and its partners, outlining shared responsibilities in carrying out program objectives and ensuring compliance with FTA guidelines. The MOU also establishes a coordinated approach to program oversight, project selection, and the efficient use of Section 5310 funds.

#### **Memorandum of Understanding (MOU)**

The MOU clarifies the roles and responsibilities of each party, including WAMPO and Wichita Transit, in administering, managing, and executing Section 5310-funded projects. Key components of the MOU include:

- **» Roles and Responsibilities:** The MOU defines WAMPO's role in assisting with the administration of funds, coordinating the application and selection process, and ensuring program compliance. Partner agencies are responsible for proposing eligible projects, maintaining accurate records, and adhering to reporting requirements.
- **» Application and Selection Process:** The MOU establishes guidelines for the submission and review of Section 5310 funding applications. A selection committee, convened by WAMPO, evaluates applications based on factors such as project need, feasibility, cost-effectiveness, and alignment with community priorities. The MOU outlines transparency and equity in the application review to ensure fair funding allocation across qualified projects.
- **» Funding and Financial Management:** WAMPO and participating organizations commit to prudent financial management practices to maximize the impact of Section 5310 funds. The MOU specifies the types of expenditures allowed, including capital and operating expenses, and defines each party's financial reporting responsibilities to ensure accurate and timely record-keeping.

- **» Project Implementation and Monitoring:** To ensure project success, the MOU mandates regular monitoring and evaluation of 5310-funded projects. WAMPO will coordinate with partner agencies to assess project progress, address any compliance issues, and ensure projects meet established timelines and outcomes. This monitoring process is critical for maintaining the effectiveness and sustainability of transportation services for seniors and individuals with disabilities.
- **» Compliance and Reporting:** In line with federal requirements, the MOU includes provisions for performance tracking, documentation, and reporting. Partner agencies are responsible for submitting regular progress reports, financial statements, and any relevant compliance documents to WAMPO. This ensures that all program activities align with federal and local standards.
- **>> Amendments and Termination:** The MOU includes clauses for modifications and amendments to address unforeseen changes in the program's operational landscape or funding levels. Additionally, the MOU sets forth guidelines for the voluntary or involuntary termination of partnerships, with provisions for an orderly transition to minimize service disruptions.
- **» Commitment to Accessibility and Equity:** An essential part of the MOU is the commitment by WAMPO and all partner agencies to prioritize accessibility and equity in transit services. The agreement encourages the development of inclusive transportation projects that meet the needs of underserved populations and promote mobility justice within the community.

#### **Executive Summary**

The TPB is asked to take action on the proposed 2025 Unified Planning Work Program (UPWP). The UPWP outlines WAMPO's transportation planning activities and tasks to be undertaken throughout the year. The draft 2025 UPWP was available for public comment from September 9, 2024, through October 8, 2024. One public comment was received.

#### **Background**

The Unified Planning Work Program (UPWP) describes what planning activities WAMPO staff and consultants will undertake, and how federal planning funds allocated to WAMPO will be used during the year (January 1-December 31). A UPWP serves several purposes, including defining the planning scope, budgeting and funding, scheduling, coordination, public involvement, and compliance. The UPWP is a crucial document for guiding and managing the transportation planning process within a metropolitan area, ensuring that resources are used effectively and that planning efforts are coordinated and transparent.

In 2025, WAMPO planning priorities and activities will include, among other things:

- >> Development of Metropolitan Transportation Plan 2050 (MTP 2050).
- >> Safety initiatives and activities, including supporting the ICT Safe Coalition, implementing the Comprehensive Safety Action Plan (CSAP), facilitating the use of awarded Safe Streets and Roads for All (SS4A) Demonstration Grant funds, and Safe Routes to School (SRTS) plan development.
- » Bicycle and pedestrian planning, including development of the Regional Active Transportation Plan.
- **»** Multimodal and Complete Streets planning to increase safe and accessible options for multiple travel modes for people of all ages and abilities.
- **>>** Public transit and paratransit planning, including completing the Regional Transit Implementation Plan.
- >> Engaging and involving the public and stakeholders in transportation decision-making in the region. Updating the WAMPO Title VI Program and Limited English Proficiency (LEP) Plan.
- » Administration of the FFY2025-FFY2028 Transportation Improvement Program (TIP).
- Transportation data collection and modeling. Updating the Regional Intelligent Transportation Systems (ITS) Architecture.
- » Participation in and support of community and planning partners on regionally significant projects.

#### **Fiscal Considerations**

Funding for the UPWP comes from various sources, including federal Consolidated Planning Grant (CPG) funds, which require a 20% local match (i.e., 80% federal funding, 20% local funding). The CPG/local-match expenditures in the 2025 UPWP total \$2,786,495.

#### **Public Participation**

WAMPO opened the public-comment period for the 2025 UPWP from September 9, 2024, through October 8, 2024. Notice of the public-comment opportunity was published in the Wichita Eagle, distributed to WAMPO's email lists, and advertised on social media. The draft 2025 Unified Planning Work Program is available on the WAMPO website and paper copies of the document are available for public review at the WAMPO offices and the Wichita Advanced Learning Library. One public comment was received and is documented below.

#### Metropolitan Transportation Plan 2050 (MTP 2050) Project List

#### **Executive Summary**

From September 15, 2023, through February 2, 2024, WAMPO held a combined Call for Projects for Metropolitan Transportation Plan 2050 (MTP 2050) and the FFY2025-FFY2028 Transportation Improvement Program (TIP). On August 13, 2024, the TPB adopted the FFY2025-FFY2028 TIP. On October 3, 2024, the Project Selection Committee (PSC) convened to recommend a fiscally constrained list of priority projects for MTP 2050. The TAC has endorsed the PSC-recommended MTP 2050 project list, which the TPB is now asked to consider for formal approval.

#### **Background**

From September 15, 2023, through February 2, 2024, WAMPO held a combined Call for Projects for Metropolitan Transportation Plan 2050 (MTP 2050) and the FFY2025-FFY2028 Transportation Improvement Program (TIP). During the Call for Projects, WAMPO member jurisdictions were invited to submit applications for near-term projects (for the TIP) and long-term projects (for the MTP) to potentially be prioritized for funding. Submissions included new projects (to the MTP, TIP, or both), as well as projects that were already listed in the current MTP, *REIMAGINED* MOVE 2040, and/or the FFY2023-FFY2026 TIP and which the member jurisdictions wanted carried over to the successor planning documents with funding priority.

WAMPO staff and the consultant team of JEO and Caliper reflected the submitted projects in the updated Travel Demand Model (TDM) for the region, so that their potential effects on future traffic conditions may be modeled. Using the outputs of the updated TDM, among other data sources, WAMPO staff and the consulting firm PEC scored and ranked the submitted projects, in accordance with the evaluation criteria adopted by the TPB on October 12, 2021, within each of nine (9) project categories. The locations and scopes of the scored projects may be found at <a href="https://www.wampo.org/mtp2050">www.wampo.org/mtp2050</a>.

Over the course of three meetings in April and May 2024, the WAMPO Project Selection Committee (PSC) made recommendations of projects to receive WAMPO-suballocated federal funding in the FFY2025-FFY2028 TIP. Those recommendations were approved by the TPB on June 11, 2024, and reflected in the final draft of the FFY2025-FFY2028 TIP, as approved on August 13, 2024.

On October 3, 2024, the PSC convened again, this time to recommend MTP 2050 priority transportation projects, especially for the time bands 2029-2038 and 2039-2050. The PSC made its recommendations in consideration of projected transportation revenues and operations & maintenance (O&M) costs, in order to ensure that MTP 2050 is fiscally constrained, as required by federal regulations. The PSC's recommendations are reflected in the draft MTP 2050 project list and fiscal constraint analysis linked below.

After the PSC made its recommendations, WAMPO staff incorporated them into draft MTP 2050 and are working with a consulting firm to ensure they are reflected in the Travel Demand Model. The TAC has endorsed the PSC-recommended MTP 2050 project list, which the TPB is now asked to consider for formal approval.

#### **Fiscal Considerations**

# Agenda Item 5B: Discussion/Updates Intelligent Transportation Systems (ITS) Architecture Update

#### **Executive Summary**

WAMPO has begun the process of updating the Regional Intelligent Transportation Systems (ITS) Architecture. Per federal guidelines, the regional ITS Architecture should be updated every 5 years. The last full ITS Architecture update for the WAMPO region was completed in 2006. Therefore, the consulting firm JEO, with subcontractor TranSystems, has been hired to assist WAMPO with updating the Regional ITS Architecture, as well as with other valuable ITS-related planning and data-sharing initiatives. The steering committee has held three meetings in Fall 2024 and plans to meet again in January 2025.

#### **Background**

WAMPO has begun the process of updating the Regional Intelligent Transportation Systems (ITS) Architecture. Per federal guidelines, the Regional ITS Architecture should be updated every 5 years. The last full ITS Architecture update for the WAMPO region was completed in 2006. Therefore, the consulting firm JEO, with subcontractor TranSystems, has been hired to assist WAMPO with updating the Regional ITS Architecture, as well as with other valuable ITS-related planning and data-sharing initiatives. The steering committee has held three meetings in Fall 2024 and plans to meet again in January 2025.

The purpose of developing a regional ITS architecture is to document ITS infrastructure, devices, personnel, and maintainers, so that planning, deployment, and communication can take place in an organized and coordinated fashion. Without such a unified framework, opportunities for improving efficiency, safety, and data-sharing may be lost; at the extreme, a region could risk deploying incompatible or redundant technologies. The ITS Architecture ensures that all stakeholders are aligned on ITS gaps and priorities.

#### **Progress**

The kick-off steering-committee meeting for the Regional ITS Architecture update was held on September 23, 2024. Given the overlap in priorities between Intelligent Transportation Systems (ITS) and Traffic Systems Management and Operations (TSMO), the 2019 WAMPO TSMO plan served as an initial basis for discussion. Steering-committee members provided feedback and discussed future ITS priorities for the region, while also identifying existing system deficiencies and areas for improvement. Based on their input and research into the existing ITS architecture, a list of needs and gaps was developed, as well as a list of potential regional ITS stakeholders beyond the steering committee.

The second steering-committee meeting took place on October 17, 2024. During this meeting, the committee reviewed the identified needs and gaps in the current ITS architecture and had an opportunity to propose solutions, future projects, or ITS-deployment strategies. Additionally, the steering committee provided input on the identified ITS stakeholders, in preparation for a larger regional stakeholder meeting.

The third steering committee meeting, held October 28, 2024, focused on opportunities for utilizing ITS data to understand and optimize the regional transportation system. Additionally, feedback was gathered on potential activities for a larger regional stakeholder meeting to be held in early 2025.

#### **Next Steps**

- » Steering committee to reconvene in January 2025
- » Regional ITS stakeholder meeting in early 2025

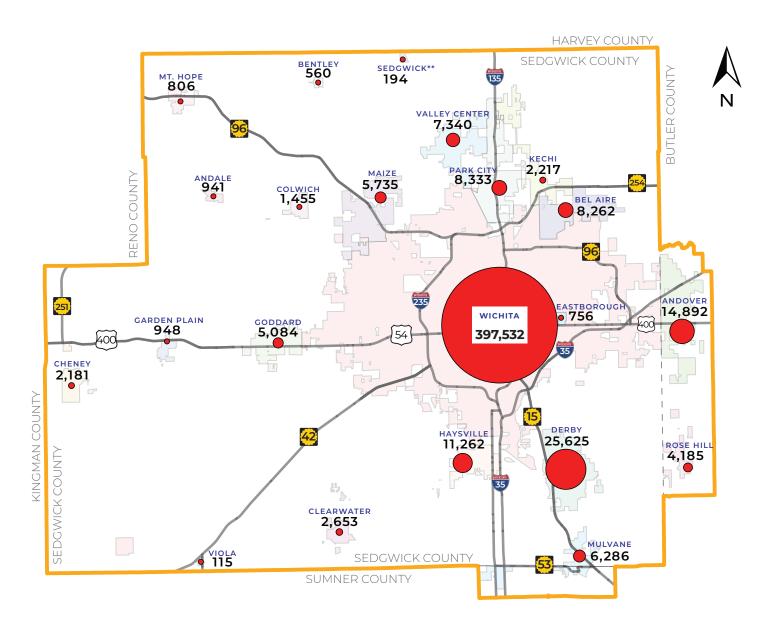


