Throughout November, Historic Bridge Awareness Month explores the spans and arches that carry goods and people across the country. Whether the trusses are only memory or stand proudly still against the horizon, Historic Bridge Awareness Month recognizes their place in the building of a nation.

We are nostalgic where bridges are concerned. They played an iconic role in building the United States. From carrying supplies West to the impressive towering trusses carrying locomotives across wide gorges, bridges took dreamers to unimaginable destinations. Through miracles of engineering, humans built solid pillars of stone and arching steel structures. But they didn't stop there. Thanks to the development of steel cable, bridges seem to float across open spans of water carrying the weight of small cities. And yet, we still explore the colorful wooden covered bridges that dot the country.

We've transformed some of our precious steel bridges from vehicle to pedestrian traffic for preservation purposes. Nostalgia has a way of making us look back while we're looking forward. Historic bridges provide a record for a community of the people who have gone before them. Preserving them is not just a sense of nostalgia, but a means of restoring an engineered structure to purposeful use.

MPOs are federally required regional policy bodies in urbanized areas with populations over 50,000. Local Updates

Closure of Amidon Bridge

Beginning Monday, October 3, the Amidon Bridge over the Arkansas River in Wichita, will be fully



closed for roughly 14 months for replacement. Although inconvenient, these repairs are crucial to the integrity of the bridge's safety. A temporary fire station, Station 23, will be enacted near 13th and West Street until the project's completion.

K-96 Project

The K-96 Improvements Project aims to upgrade the K-96 corridor between I-135 and I-35. Improvements are needed to increase freeway capacity, enhance reliability and relieve traffic congestion to keep Kansans moving.

The project will include reconstructing roughly 2.5 miles of East Kellogg from K-96 to just east of 159th Street. Work will include adding travel lanes and frontage roads, interchange improvements at K-96 and grade-separated intersections at 143rd and 159th Streets.

Economic Development RFP Plan out

WAMPO has issued the Economic Development RFP and will be accepting proposals until November 4th. The Economic Development Report will help WAMPO and our agency partners to respond to the economic growth and production of assets that improve the quality of life and realize the connectivity between communities. The project will include the review of relevant community demographic and economic data, a SWOT analysis of our local economy, community visioning, and stakeholder group engagements to capture the vision of our residents, and the region's capacity for additional growth. TIP Amendment 1

Amendment #1 to the WAMPO FFY2023–FFY2026 Transportation Improvement Program (TIP) was a regularly scheduled amendment adding five new projects and modifying nine existing projects. The Public Comment period for Amendment #1 was open from September 3, 2022, through October 2, 2022. No public comments were received. It was approved by the Transportation Planning Body on October 11, 2022. The FFY2023–FFY2026 TIP took effect on October 1, 2022 and may be found at www.wampo.org/transportation-improvement-program.

TIP Amendment 2's call for changes will start November 28, 2022, followed by the Public Comment Period currently set to begin on December 24th.

Population Forecast

Population forecasts are mainly developed and utilized by planning departments and metropolitan planning organizations. Public works departments rely on accurate forecasts for long-term planning of sewer and water. Forecasts play a role in assisting developers with understanding potential demand and the best areas for commercial and residential development. School districts also use population forecasts when planning for new schools or capacity revisions needed to current schools. These population forecasts will be used in the MTP 2050 planning process and Travel Demand Model Update.

Metropolitan Transportation Plan 2050

The Metropolitan Transportation Plan (MTP) sets a vision and strategy for all regional transportation decision-making over the next 20 years. Updated every five years, the plan includes a multimodal list of priority transportation projects and strategies that fit within the region's anticipated funding capacity. The update will reflect new planning priorities and changing patterns in population and economic growth that may impact the multimodal transportation system. The current MTP was approved in June 2020 and the next plan adoption will occur in Spring/Summer 2025. Because the MTP requires extensive data analysis and public engagement we need an early start on updating. In July 2022, WAMPO staff kicked off the MTP update process. Comprehensive Safety Action Plan

A Comprehensive Safety Action Plan (CSAP) is a data-driven framework for reducing fatalities and serious injuries. The plan identifies and prioritizes a comprehensive set of projects and safety improvements that address safety issues and minimize the potential for crashes. The CSAP process will include extensive community engagement and analysis of crash data and best practices to identify the greatest risk contributing to fata and sever injury crashes for all modes of transportation on the transportation network.

WAMPO has issued a Request for Proposal (RFP) seeking a consultant to help develop a CSAP for the WAMPO region. Travel Demand Model Update

A critical part of transportation planning is anticipating possible future transportation needs. To that end, WAMPO maintains a Travel Demand Model (TDM) for the Wichita metropolitan area. In addition to WAMPO using TDM outputs in the development of its own planning documents, member jurisdictions may also request that it be used to model specific scenarios of relevance to their transportation programs. In anticipation of the next update to the Metropolitan Transportation Plan (MTP), which is due by June 2025, WAMPO has begun a project to update and improve the TDM, working with the consulting firm JEO Consulting Group, Inc. This TDM-update effort began in September 2022 and is anticipated to run through April 2024.
