I. Welcome

III. Agenda Items

A. Regional Transit Implementation Plan

Dora Gallo, WAMPO, announced that a series of public meetings for the Regional Transit Implementation Plan will be held on June 5, 2024, to discuss service alternative concepts and gather feedback. B. Review and Discussion of Toolkit Work Completed by Subcommittees

Jessica Warren, WAMPO, reviewed the Toolkit Writing and Data Collection subcommittee assignments, timeline, and tasks. An overview of the draft UCTC Toolkit contents and format was presented.

C. Discussion of Toolkit Finalization, Collection of Key Stakeholders and Storytellers, and Motivational Stories

Ms. Warren invited attendees to partake in an interactive activity identifying key stakeholders and storytellers. Participants wrote down stakeholder/storyteller organizations or individuals and contact information (if known) on Post-It notes that were then added to either the stakeholder or storyteller posters on the wall. Online attendees sent their ideas in the chat.

Ms. Warren asked UCTC members to collect the story of one of the storytellers they had listed, either written or in a video, and to take it to one of the identified stakeholders for discussion, and to report back at the next UCTC meeting in August 2024.

D. PolicyMap Overview

Ms. Warren pulled up the PolicyMap that UCTC member Jessica Hutton had hoped to share with the Coalition, and shared roughly 15 minutes of a webinar recording that explains how to use the map.
