#### C. Director's Report

#### i. Comprehensive Safety Action Plan and Open House Update

Ashley Bryers said WAMPO and a consultant team are developing a Comprehensive Safety Action Plan (CSAP) for the region. In support of that effort, they are putting together a Planning and Demonstration grant application for the Safe Streets and Roads for All (SS4A) discretionary grant program, due on July 10, 2023. A related Transportation Safety Committee/public workshop will be held on June 8, 2023.

Chad Parasa provided an overview of the CSAP open house.

#### ii. Projects Submitted for Carbon Reduction Program Funding

Chad Parasa said on May 1, 2023, WAMPO concluded a Call for Projects for Carbon Reduction Program (CRP) funds totaling approximately \$3.9 million. Six projects were submitted for possible funding from Wichita, Maize, Bel Aire, Valley Center, and Sedgwick County. The Project Selection Committee (PSC) met to consider these projects on June 12, 2023. Their recommendations will be submitted to the Technical Advisory Committee (TAC) on June 26, 2023, and the TPB on July 11, 2023, for final action.

#### iii. FFY2023 TIP Amendment #4 Call for Changes Open (6/5/23-6/16/23)

Chad Parasa said the call for changes is open through Friday, June 16, 2023.

#### iv. MTP 2050 Public Engagement Update

Ashley Bryers said for the first round of public engagement for Metropolitan Transportation Plan 2050 (MTP 2050), a survey about the current state of transportation and the future of transportation needs in the WAMPO region is available at <a href="https://www.wampo.org/mtp2050">www.wampo.org/mtp2050</a>.

Ms. Bryers noted that the WAMPO team has participated in a variety of events. As of June 13, five popup events have been held. WAMPO staff presented at all six Wichita District Advisory Board meetings. There are several listening sessions scheduled for the rest of June and some in July. Most of the listening sessions are tailored to specific groups; however, WAMPO is facilitating two listening sessions that are open to the public. Ms. Bryers extended an invitation to members of the TPB to participate. The aim is to figure out what people want for transportation in our area.

#### v. Innovation Presentations

Chad Parasa said, per the advice of the WAMPO TPB Chair, presentations are encouraged from regional member jurisdictions and regional partners on "Innovation and Innovative Projects." He extended an invitation for organizations to share their innovative projects. He stated that staff would be in touch regarding making innovation presentations in the future.

#### vi. Federal Certification Review

Chad Parasa provided an update on the two-day Federal Certification Review. He noted the stakeholders that participated, including the Federal Transit Administration, Federal Highway Administration, and KDOT partners. Mr. Parasa said the review consists of evaluating various impacts that the transportation system has [such as] how we monitor transportation in our region; how we manage public processes; how is funding spent; and [additional] details. He shared that the report would soon be documented and distributed. Chair Tuttle praised WAMPO for a smooth review.

#### vii. Regional Transit Implementation Plan

Chad Parasa said WAMPO is completing a study to determine what regional transit looks like. WAMPO recently met with the Consultant Selection Group which will make their final determination about who will lead the RTIP project. WAMPO should have a contract for the selected firm at the next TPB meeting scheduled for July 11, 2023.

#### D. Consent Agenda

#### i. Brent Clark as Freight Representative on TAC

Chad Parasa said the TAC has open positions. One position available is freight. TPB approves several of the positions on TAC, thus WAMPO staff is seeking TPB approval for Brent Clark, Valley Center City Administrator, to become the freight representative on TAC.

#### 4. Action

#### A. 2023 Unified Planning Work Program Amendment 2

Ashley Bryers said a version of Amendment 2 to the WAMPO Unified Planning Work Program (UPWP) was reviewed by the TAC in April but was not taken before the TPB for their approval because additional changes to the UPWP needed to be added to the amendment. The TPB was asked to vote on the revised, proposed Amendment 2 to the 2023 UPWP to consolidate travel line items, adjust all staff line items to reflect actual hours worked, adjust the budget to accommodate anticipated expenditures based on planned work, add \$110,000 for "Consulting Services: Accounting Services" to the budget, and add the development of bicycle/pedestrian-facility maps for public use using the latest technology, such as mobile apps. The public comment period was from 5/17/2023 through 6/1/2023. No public comments were received. The TAC recommended approval at their May 22nd, 2023, meeting.

Ms. Bryers reported that the original UPWP was approved in December and the first amendment was completed in March. The UPWP requires a 20% local match, and if approved, the UPWP would total \$2,518,450. The TAC recommended approving the UPWP as presented.

#### 5. Discussion/Updates

#### A. KDOT Safe Systems Approach: Post-Crash Care

Vanessa Spartan, from KDOT, said post-crash care has the aim to get EMS to crash scenes and emergency trauma to save lives.

Susan DeCourcy, from the National Highway Traffic Safety Administration (NHTSA), presented the Safe System Approach. It has 6 principles and 5 elements. Post-crash care enhances the survivability of crashes and prevents secondary crashes. Key post-crash care includes the timely

arrival of emergency responders and well-trained EMS clinicians is especially critical in tribal communities and rural areas. One question was posed regarding the optimal time to get to a crash. Ms. DeCourcy responded that for every additional minute, there is an increase in motor vehicle mortalities.

Ms. Spartan said efforts are underway in the Kansas Department of Transportation (KDOT) to address Post-Crash Care. KDOT funds Traffic Incident Management (TIM)meetings and recently had a session panel at the KDOT Traffic Safety Conference about post-crash care. The safe system approach will be implemented in 2024. KDOT is providing local match to support local agencies in applying for Safe Streets and Roads for All (SS4A) discretionary funds. The Kansas Board of Emergency Medical Services (KBEMS) links crash data with Emergency Medical Services (EMS). The KBEMS is also working on crash notification. Currently, if someone is seriously hurt in a crash, they cannot call for help. The new crash notification system will utilize telematic data, which will send a notification that a crash has occurred and someone is in need of help. The KBEMS also aims to link telematic data to patient care reports. In addition, the telematic data will map where crash victims do and do not have timely care, which KBEMS can use to develop travel time matrices and recommendations for agency consideration.

Craig Compton, of the Center for Economic and Business Research (CEDBR) provided a presentation regarding the CEDBR's socioeconomic and demographic findings for the WAMPO region, including housing affordability, employer retention, and attraction factors, and key corridors serving the WAMPO area.

#### 6. Committee & Partnership Updates

#### A. Executive Committee

Chair Tuttle announced that the Executive Committee met on May 4th, and the next Executive Committee meeting will be on August 3rd, 2023, at 11:00 AM. Anyone can join or participate in this meeting; they do not have to be a member.

#### **B.** Transit Spotlight: Derby Dash

Jenny Foster-Farquhar provided an overview of the Derby Dash and the impact they've had thus far. She reported that the Derby Dash provides an on-demand response service. They employ one full-time transportation coordinator, five part-time drivers, one full-time vehicle, and one backup vehicle. The latest data through May 2023 shows that Derby Dash has served nearly 3,000 people by providing them with 3, 475 rides. Ms. Foster-Farquhar reported that most rides are for medical appointments, such as dialysis, while others are to access employment, community supports and services, and transportation to and from local schools. Since school is out, Derby Dash currently transports school-aged children to summer camp.

#### C. Kansas Department of Transportation (KDOT)

No report.

#### D. Wichita Metro Division, KDOT

Tom Hein provided updates about the new flyover ramp that opened on northbound I-135. He reported the luminaires on the bridge are not lit yet, as KDOT is waiting on Evergy. There is other lighting in the area, [and the lighting in the area] will improve as they get service from Evergy on luminaires. Meanwhile, the flyover has made the commute for people in Maize and west Wichita better. It's important to note the old loop will be closed as of Wednesday, June 14. If drivers miss the exit to the new flyover people will need to do U-turn at 53<sup>rd</sup> Street to get back on southbound 235. You can find updates on WichWay.org.

Bryan Frye asked what could be done to help people use the right lane without deferring to the temporary signs. Mr. Hein said people will have to get used to it. Closing the loop ramp will help people go to the right lane.

Jim Howell said the reflectivity at nighttime is extremely poor on the direction signs; do you plan to replace those? There doesn't appear to be anything happening. Mr. Hein responded that KDOT has replaced them over time because they do lose reflectivity. However, it is an expensive project.

Lastly, Chair Tuttle noted that WAMPO was mentioned in the Wichita Business Journal and the Beacon for its involvement in the North Junction project.

#### **Executive Summary**

The WAMPO TIP Policy includes a Reasonable Progress Policy, under which projects receiving WAMPO-suballocated funding in the current FFY or that received it in a past FFY but are not completed are to have bimonthly progress reports to the TAC/TPB. This is the progress report to the TPB for July 2023.

#### **Background**

Page 23 of the WAMPO Transportation Improvement Program (TIP) Policy (Appendix I of the FFY2023-FFY2026 TIP, <a href="https://www.wampo.org/files/ugd/bbf89d\_646ba786b67646b98cfe14f74bcc0277.pdf">https://www.wampo.org/files/ugd/bbf89d\_646ba786b67646b98cfe14f74bcc0277.pdf</a>) establishes a Reasonable Progress Policy. This policy states that projects programmed to receive WAMPO-suballocated funding that are scheduled to start in the current Federal Fiscal Year (FFY) or that have started but not finished (including projects that started in prior FFYs) are supposed to have progress reports at least every two months. The attached project statuses have been reported for the July 2023 bimonthly report to the TPB.

The Reasonable Progress Policy was revised by the TPB on April 11, 2023, but these bimonthly progress reports were kept as part of it.

#### **Executive Summary**

WAMPO and a consultant team are developing a Comprehensive Safety Action Plan (CSAP) for the region. In support of that effort, they are putting together a Planning and Demonstration grant application for the Safe Streets and Roads for All (SS4A) discretionary grant program, due on July 10, 2023 (staff submitted the application on June 30).

#### **Background**

WAMPO is in the process of developing a Comprehensive Safety Action Plan (CSAP). Upon its expected adoption in late summer/fall 2023, the WAMPO region will be eligible for U.S. Department of Transportation (USDOT) discretionary Safe Streets and Roads for All (SS4A) Implementation grants. Additional information about the Comprehensive Safety Action Planning process is available at <a href="https://www.wampo.org/safety">www.wampo.org/safety</a>.

The SS4A Notice of Funding Opportunity (NOFO) for this year was published earlier than expected, with the result that grant applications are due on July 10<sup>th</sup>, 2023, prior to the expected adoption of the WAMPO CSAP, meaning the WAMPO region will not be able to apply for any Implementation grants during this round of funding. Instead, WAMPO staff and consultants are putting together a Planning and Demonstration grant application. WAMPO intends to then apply for an Implementation grant in 2024 or 2025.

Staff submitted the SS4A Planning and Demonstration grant on June 30, 2023.

#### **Executive Summary**

WAMPO is developing an Electric Vehicle Plan for the region. The plan-development process is currently in the public engagement phase, for which a public survey has been launched that will help WAMPO understand needs and identify potential goals and strategies for this plan.

#### **Background**

#### **Executive Summary**

The 2023 Unified Planning Work Program (UPWP) budgets for the planning activities WAMPO intends to undertake this year and lists priorities and activities for the year. This staff report provides statuses of planned work tasks, which will be updated quarterly. This update is for the second quarter of 2023. Also provided is the 2023 second-quarter UPWP activity report that will be submitted to KDOT.

#### **Background**

The WAMPO 2023 Unified Planning Work Program (UPWP) was approved at the December 13, 2022, Transportation Policy Body (TPB) meeting and amended at the March 14, 2023, meeting. The UPWP is the primary budgeting document for planning activities WAMPO will undertake during the calendar year.

The table below shows priority projects in the 2023 UPWP, the quarters in which they are to be completed, and their current statuses. This table will be updated and presented to the TPB quarterly.

#### **Fiscal Considerations**

Funding for the UPWP comes from various sources, including federal Comprehensive Planning Grant (CPG) funds, which require a 20% local match (i.e., 80% federal funding, 20% local funding). The total expenditures budgeted in the 2023 UPWP are \$2,518,450.

#### **Executive Summary**

WAMPO staff recommends entering into a contract with Method Productions to provide video creation services through December 31, 2023, for not to exceed \$49,604.66. The number of videos to be produced in 2024 and 2025 will be negotiated prior to the start of each of those years, with a budget for each year not exceeding \$50,000.

#### **Background**

Video is the best medium to make connections with people. WAMPO's small staff (currently thirteen employees) does not have the ability to create multiple videos per year. Therefore, WAMPO staff recommend hiring a consultant to provide WAMPO with video creation services for 3 years (2023, 2024, and 2025). The number of videos to be produced in 2023 is specified in the attached contract. The number of videos to be produced in 2024 and 2025 will be negotiated prior to the start of each of those years.

The Consultant will assist WAMPO by:

- » Developing creative videos through filming, editing, voiceovers, storyboarding, and writing scripts.
- **»** Developing live-action videos, 2D & 3D animation, whiteboard graphics, and/or motion-graphics animation.
- **»** Developing videos for WAMPO's website, social media, outreach events, etc. The lengths of the videos will depend on the medium. Social media videos could be extremely short versus an explainer video.

Following a competitive bidding process, the winning consultant was Method Productions.

#### **Fiscal Considerations**

The not-to-exceed dollar amount for the contract lasting through December 31, 2023, is \$ 49,604.66. This funding is programmed in the 2023 UPWP under subtask 2.6, "Consultant Services: Video Creation Services." The same project will also be programmed and funded at the same level in the 2024 and 2025 UPWPs.

#### **Executive Summary**

WAMPO staff recommends entering into a contract with SRF Consulting Group with Nelson Nygaard and Shockey Consulting to develop a Regional Transit Implementation Plan through December 31, 2024, for not to exceed \$149,922.11. Consultants will collaborate with the United Community Transit Coalition (UCTC) and engage with transit agencies and decision-makers to establish a coordinated regional transit network.

#### **Background**

This plan will build upon the Connecting Communities: Wichita Area Transit Feasibility Study (2018) and act as a companion to the Wichita Transit Network System Redesign Study and the Coordinated Public Transit Plan. The plan will involve coordination and consensus-building with transit agencies, the United Community Transit Coalition (UCTC), and decision-makers for the implementation of a regional transit network.

The 2018 Study concluded that residents in Derby, Haysville, and Maize support having transit in their cities. The Consultant shall identify additional WAMPO-region cities to mimic the analysis of the 2018 Study to gauge the residents' support/need for transit services.

The Consultants will develop, through collaboration, a plan to implement a regionally coordinated transit network with the cities whose residents support having/need public transit. Consultants will help transit agencies/providers and decision-makers identify an implementation strategy for providing regional transit services.

Following a competitive bidding process, the winning consultant was SRF Consulting Group with Nelson Nygaard, and Shockey Consulting.

#### **Fiscal Considerations**

The not-to-exceed dollar amount for the contract lasting through December 31, 2024, is \$149,922.11. This funding is programmed in the 2023 UPWP under subtask 3.4, "Consultant Services: Regional Transit Feasibility Study".

#### **Executive Summary**

On June 12, 2023, the WAMPO Project Selection Committee (PSC) met and made project-funding recommendations that the TAC, on June 26, 2023, voted to forward to the TPB for final action. First, in response to submissions for a special Call for Projects (March 1-May 1, 2023), they recommended five (5) specific projects to which to award approximately \$3.9 million (cumulatively) of Carbon Reduction Program (CRP) funds in FFY2024-FFY2025. Then, they recommended permitting \$131,559 of unused Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA) from the WAMPO project "WAMPO Travel Demand Model Update" to be placed on a "phase 2" TDM-update project, provided that recent Federal legislative actions allow it.

#### **Background: CRP Funds**

WAMPO has a new suballocated funding program, the Carbon Reduction Program (CRP). Following a special Call for Projects (March 1-May 1, 2023), the WAMPO Project Selection Committee (PSC) met on June 12, 2023, and made recommendations to the TAC and TPB on which projects should receive funding from this new source. During the Call for Projects, six projects were submitted (see attached table and map).

#### **Available Funds and Eligible Uses**

When the Bipartisan Infrastructure Law (BIL) was enacted in late 2021, it created the <u>Carbon Reduction</u> <u>Program (CRP)</u>, which funds transportation projects that are expected to reduce carbon dioxide emissions. A summary of the types of projects that qualify for CRP funds may be found in the CRP Call for Projects flyer (see attached).

Each year, a portion of the CRP funds allocated to Kansas are suballocated to WAMPO to award to specific projects, in a similar fashion to WAMPO's other suballocated funding programs (Surface Transportation Block Grant (STBG), Congestion Management and Air Quality (CMAQ), and Transportation Alternatives (TA)). Due to delays in the creation and distribution of Federal and State guidance on the program, WAMPO now has three years' worth of CRP funding to distribute:

#### **Background: CRRSAA Funds**

In Federal Fiscal Year (FFY) 2022, \$700,000 of Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA) funds were obligated on the WAMPO project "WAMPO Travel Demand Model Update". However, the contract with the consulting firm selected to carry out the project was ultimately for only \$568,441. Therefore, *contingent on State and Federal rules and procedures allowing it*, 1 WAMPO staff proposed to the PSC to deobligate the excess funds and reprogram them onto a "phase 2" project, starting in FFY2024, that would continue the work of keeping the Travel Demand Model (TDM) up to date.

#### **Proposed Project Title**

WAMPO Travel Demand Model Update Phase 2

#### **Proposed Funds to Use on Project**

\$131,559

#### **Proposed Year of Obligation**

FFY2024

#### **Proposed Project Scope**

- 1. Conduct routine model maintenance and testing for errors. This will include working with a model-validation taskforce made up of representatives from WAMPO member jurisdictions and planning partners to get their input on updates to the model.
- 2. Keep the model and its input data up to date and account for current and future changes in the transportation network and future development of the Wichita region. Sources of updated information could include, but are not limited to, the following:
  - a. Updates made to the model by other users, including KDOT, local governments, and consultants retained by KDOT and/or local governments for planning and engineering work.
  - b. Road-centerline Geographic Information System (GIS) data, American Community Survey data, traffic-count data, building-permit data, and transit-route data.
- 3. In response to requests from WAMPO planning partners and member jurisdictions, provide maps, Excel spreadsheets, GIS shapefiles, and text with analysis regarding the model's outputs, performance measures, and degree of sensitivity under its current configuration. Requested data types may include, but are not limited to, average travel speeds, travel times, link delays, capacities, and levels of service. Subarea analyses may also be requested.

For WAMPO studies and reports, provide maps, Excel spreadsheets, GIS shapefiles, and text with analysis regarding the model's outputs, performance measures, and degree of sensitivity under its current configuration. This may include, but is not limited to, average travel speeds, travel times, link delays, capacities, and levels of service. Subarea analyses may also be requested.
- 5. Attend WAMPO committee meetings and meetings with WAMPO regulators, planning partners, or stakeholders, as requested by WAMPO staff, to speak about the model and its uses, data requirements, and outputs, either with or without WAMPO staff present.
- 6. Participate in meetings with the WAMPO project manager to review progress, answer questions, and plan next steps on a regular basis.

#### **Fiscal Considerations: CRP Funds**

**»** FFY2022 CRP funds are required to obligate no later than the end of FFY2025. The TAC's recommendations would result in all unawarded FFY2022, FFY2023, and FFY2024 CRP funds being obligated before they expire, in either FFY2024 or FFY2025.

#### Fiscal Considerations: CRRSAA Funds

» CRRSAA funds are required to obligate no later than the end of FFY2024. The TAC's recommendation on the use of CRRSAA funds would make it possible for unused funds to reobligate before they expire, depending on the outcome of recent federal legislation. Because CRRSAA funds may be used for up to 100% of a project's cost, WAMPO's operating budget would not be adversely affected.

#### **WAMPO CRP Call for Projects**

The Wichita Area Metropolitan Planning Organization (WAMPO) has opened a special Call for Projects, **March 1-May 1, 2023**, for transportation-project funding that is available through the new federal Carbon Reduction Program (CRP). The CRP is geared specifically towards projects that are expected to reduce transportation-related carbon dioxide emissions (the full FHWA guidance on the program may be found at <a href="https://www.fhwa.dot.gov/bipartisan-infrastructure-law/crp.cfm">https://www.fhwa.dot.gov/bipartisan-infrastructure-law/crp.cfm</a>).

#### The following activities may qualify for CRP funding:

- >> Establishing or operating a traffic monitoring, management, and control facility or program, including advanced truck stop electrification systems
- >> Public transportation (including capital projects for the construction of a bus rapid transit corridor or dedicated bus lanes)
- A Transportation Alternatives project, including construction/planning/design of on-/off-road trail facilities for pedestrians, bicyclists, and other nonmotorized forms of transportation
- Advanced transportation and congestion management technologies
- **»** Deployment of infrastructure-based Intelligent Transportation Systems capital improvements and the installation of vehicle-to-infrastructure communications equipment, including retrofitting dedicated short-range communications technology deployed as part of an existing pilot program to cellular vehicle-to-everything technology
- » A project to replace street lighting and traffic control devices with energy-efficient alternatives
- **»** Supporting congestion pricing (shifting transportation demand to nonpeak hours or other transportation modes, increasing vehicle occupancy rates, or otherwise reducing demand for roads, including electronic toll collection, and travel demand management strategies and programs)
- >> Efforts to reduce the environmental and community impacts of freight movement
- Supporting deployment of alternative-fuel vehicles, including the acquisition/installation/operation of public electric-vehicle charging infrastructure or hydrogen/natural gas/propane vehicle fueling infrastructure and the purchase/lease of zero-emission construction equipment/vehicles, including the acquisition/construction/leasing of required supporting facilities
- » A project for a diesel engine retrofit
- >> A project to improve traffic flow that is eligible under the CMAQ program, and that does not involve construction of new capacity
- » Reducing transportation emissions at port facilities, including through port electrification
- » None of the above, but the project would reduce CO₂ emissions over its lifecycle
  - o For projects of this sort, the submitter is required under FHWA guidance to provide and document calculations of potential reductions in CO<sub>2</sub> (as opposed to any other greenhouse gas) emissions that would result from completion of the project over its lifecycle

Even though calculations and documentation of potential  $CO_2$  reductions are not a requirement for all of the above qualifying activities, all submitters are strongly encouraged to provide them, if possible, as reducing  $CO_2$  emissions from transportation is the primary purpose of the CRP.



#### **Executive Summary**

WAMPO's Reasonable Progress Policy requires sponsors of projects programmed to receive WAMPO-suballocated funding in the current FFY that are not yet obligated to present on their statuses to the TAC at their first meeting after May 31 and to the TPB at their first meeting after that. In FFY2023, one Haysville project, one Wichita project, and one Valley Center project fall into this category.

#### **Background**

Page 23 of the WAMPO Transportation Improvement Program (TIP) Policy (Appendix I of the FFY2023-FFY2026 TIP, <a href="https://www.wampo.org/files/ugd/bbf89d\_646ba786b67646b98cfe14f74bcc0277.pdf">https://www.wampo.org/files/ugd/bbf89d\_646ba786b67646b98cfe14f74bcc0277.pdf</a>) establishes a Reasonable Progress Policy. This Reasonable Progress Policy was revised by the TPB on April 11, 2023. One of the changes made on that occasion was to establish that:

"At the TAC meeting following May 31st and the TPB meeting following that TAC meeting, project sponsors with projects in the current FFY not obligated will be required to present their project's status, both verbally and in writing, and be available to answer questions from the TAC and TPB. On this occasion, they may also request additional time to obligate, if necessary."

There are three Federal Fiscal Year (FFY) 2023 projects that, as of June 2023, had not yet obligated their WAMPO-suballocated funds, meaning the sponsors of those projects are required to report on their statuses to the TAC and TPB both in writing and verbally:

- >> Haysville: "Seneca & 63rd Street Bike Ped Pathway"
- >> Wichita: "West St., Harry to Pawnee"
- >> Valley Center: "Meridian, from Ford (77th St. N.) to Seward (69th St. N.) and Main to 5th (85th St. N.)"

The project sponsors reported on these projects' statuses to the TAC on June 26, 2023, and must now do the same for the TPB.

This project is an arterial street reconstruction project on Meridian Ave, which is the primary north/south arterial running through Valley Center. There are two segments to the project:

- South Segment: 0.25 mi south of 69<sup>th</sup> Street North to Railroad Tracks (just north of Ford St) Reconstruct to a 4-lane paved section, with curb and gutter, and construct a 10- foot multiuse path on west side of street.
- North Segment: Main to 5<sup>th</sup> St
   Reconstruct to a 2-lane paved section, with parallel parking and curb and gutter, and construct an 8- foot multiuse path on west side of street.

#### **Status / Schedule Update**

- Engineering Design: The project is in the final design stage, with Plans, Specifications, and
  Estimates (PSE) due to KDOT on June 5. Our contracted engineering firm doing the design for
  this project anticipates providing the PSE to KDOT by June 5. In our experience, KDOT usually
  returns their comments on PSE Plans within several weeks. Once our engineer receives KDOT's

#### **Executive Summary**

The Section 5310 grant program provides federal funding to enhance transportation options for seniors and individuals with disabilities in the United States. It supports services beyond traditional public transportation and aims to improve access to essential services and community activities. Funding can be used for vehicles, operational costs, training, and transportation plans. Wichita Transit manages the Section 5310 grant program for the region, with available funding from 2021 and 2022 allocations totaling \$1,077,144. WAMPO led the call for projects and grant selection process.

#### **Background**

The Section 5310 grant program, also known as the Enhanced Mobility of Seniors and Individuals with Disabilities program, is administered by the Federal Transit Administration (FTA). It provides funding to states and localities to enhance mobility options for seniors and individuals with disabilities.

The program focuses on supporting transportation services that go beyond traditional public transportation, such as paratransit, wheelchair-accessible vans, and other specialized vehicles. The goal is to improve access to essential services and community activities for individuals who may face challenges using regular fixed-route public transportation. Funding through the Section 5310 grant program can be used to purchase vehicles, support operating costs, provide training for drivers, and develop transportation plans that address the specific needs of seniors and individuals with disabilities.

While Wichita Transit is the designated recipient of 5310 funding, WAMPO led the call for projects and grant selection process. This year's Section 5310 program in the WAMPO region has funding from the allocations for Federal Fiscal Years (FFYs) 2021 (\$436,945) and 2022 (\$640,199), totaling \$1,077,144. The program timeline for this year's funding is July 1, 2023 - June 30, 2025.

WAMPO opened the call for projects on December 1st, 2022. It closed on February 28th, 2023. A workshop was held on December 8th, 2022. After the submission deadline, a selection committee comprised of three community members independently assessed each project's merits and assigned scores based on predefined criteria. These criteria included factors like a demonstration of need, addressing accessibility and/or collaboration goals, meeting specific needs of older adults/disabled individuals, and Coordinated Transit District #9-member status. The committee then met to discuss the projects and share their individual scores. This collaborative session allowed for a comprehensive evaluation and facilitated the selection process. By sharing their scores, the committee members could compare assessments, provide insights, and reach a consensus on the most promising projects.

The project selection committee's assessment was crucial in determining the final selection of projects that would receive funding. The committee's expertise and dedication ensured a fair and objective evaluation of


